SUBJECT: PARK NAMING REPORT

RECOMMENDATION

THAT the Board name the park site at Alexander Street and the Main Street Overpass "Wendy Poole Park."

POLICY

The Park Board's Guidelines for Naming Parks is attached as Appendix I.

BACKGROUND

In the first instance for naming parks, the Guidelines suggest using bounding streets for ease of navigation. Since Alexander Park is so similar to Alexandra Park, located at Bidwell and Beach, it is appropriate to pursue another naming approach in this case.

This small space of .43 hectares (just over 1 acre) is located in Gastown north of the railroad tracks on a steeply sloping "bench" land. It is owned by the Vancouver Port Authority but is leased to the City for a 49-year term that commenced on September 1st, 1986. Plans for redevelopment of the area were approved by the Park Board in September 1999 and are progressing with the Engineering Department's construction of a new retaining wall which is critical to further development of the site. Plans for landscaping include grassy areas, irrigation, trees, benches and pathways plus bright lighting. The costs for the landscape improvements are anticipated to be \$40,000.

DISCUSSION

In February 2000 the Park Board received a letter from the Crab- Water for Life Society requesting that the Alexander Street park site be formally named after Wendy Poole. Ms. Poole was a young First Nations woman from northern British Columbia who was one of two dozen women whose murders in the Downtown Eastside have remained unsolved. Her body was discovered in a dumpster a block away from the park area in 1989. Mr. Larson of the CRAB Society feels that she is representative of a terrible malaise in the area and that the naming will help bring to light the plight of these forgotten women.

In early March staff, working through the Vancouver East District Office and the Strathcona, Carnegie and Ray Cam Community Centres, initiated a public process with respect to the naming of the site. This was accomplished through posters and newsletters in the area. As a result of this and a further initiative in July involving a canvassing by fax of organizations within the park's neighbourhood, we received nine formal letters of support for the name Wendy Poole and a phone call from the Gastown Police detachment who also are in favour of that name. The Police Officer had also been in touch with the family of Wendy Poole who reside in a small village in Northern BC who gave consent to the naming if it was favourably decided upon by the Park Board.

Other names were suggested as attached (included in Appendix 2 along with an original request letter) but none with the same level of support as that for Wendy Poole.

The Crab - Water for Life Society has pledged to sponsor an inscribed boulder for the park whose final wording would be approved by Park Board staff if the park is named for Wendy Poole.

SUMMARY

Your consideration of naming the park site at Alexander and the Main Street Overpass has been initiated by representatives of the local community and is within the established guidelines for the naming of parks, trails, roads or other features.

GUIDELINES FOR NAMING PARKS, TRAILS, ROADS OR OTHER FEATURES COMING UNDER THE PARK BOARD'S JURISDICTION

- 1. In the first instance, the park, trail, road or other feature being named generally should relate to a "constant" feature either nearby or within that park. This could relate to a bordering street name or a natural or man-made feature. This does not preclude the consideration of a name already in "common" use for the park. Criteria such as the above gives ease of identification with relation to the park.
- 2. When no such "constant" feature is present or it is desired to commemorate an historical event or person important to the Park Board, City of Vancouver, or a person having made a substantial donation to the Park Board, a park may be named for that person.
- When deemed appropriate, the Park Board will submit a short list of suggested names to concerned community groups for their input regarding the selection of a name.

She was a past vice-president of DERA, had an extensive background in the labour movement locally and internationally, volunteered enthusiastically with the Four Sisters Co-op, where she spent her final years, and was very active with the Vancouver Status of Women organization.

Harry Rankin Q.C.: Is not only a Vancouver "institution"

for his many years of public service as a city councillor, but also, as a trial lawyer, has for many years represented low-income and other disadvantaged people for little or no recompanse; people who would otherwise be denied access to the courts. His offices at 157 Powell, immediately adjacent to the proposed park have been located at this site for many years. His unwavering commitment to social justice and poverty issues spans 50 years or more and he remains active and vigorgunaevery day in these much valued endeavours.
