- · Conduct survey regularly

Employee Engagement Survey

Implementation Plan

- Develop task group comprised of representatives – staff, unions, City HR
- Engage a consultant, estimated costs \$50-\$70,000
- 5-6 months process May to October
- Repeat process every 2 or 3 years
