## MOTION

### **Embedding Information Regarding Park Names in the Fabric of Parks**

Moved by Commissioner Barnes,

Whereas the Vancouver Board of Parks and Recreation has a practice of naming our parks after people who have made significant contributions to the citizens of Vancouver;

Whereas information regarding the nature of those contributions is not easily available to people enjoying our parks;

Whereas this information would be of interest to our park users, will add to social cohesion and cross-cultural understanding and contribute to the historical understanding of our parks;

Therefore be it resolved that staff explore opportunities of embedding information regarding park names into the fabric of our parks; potentially through such strategies as engraved boulders, signage, recycled materials etc.

A Board member advised that it is important to educate people on the history of our parks and give them the opportunity to learn about Vancouver parks.

A Board member asked whether this would mean that every park would have to be evaluated to see if an information piece was necessary. Staff advised that if the motion passed, staff would come back to the Board with a recommended policy to ensure that there is a streamlined process involved in which parks are selected.

The Board discussed the motion. A few Board members expressed support for the motion and were surprised that this idea had not come to the Board sooner.

# The motion was put forward and it was CARRIED UNANIMOUSLY.

# **Enquiries, Other Matters and New Business**

A Board member asked whether it was possible to remove branches from the lower parts of trees in Sparwood Park so that there could be a line of visibility through the park to see the elementary school. Staff advised that they would see if that was possible.
