## MOTIONS

### 1. Discounted Rates and Fees for Persons with Disabilities

MOVED by Commissioner De Genova  
SECONDED by Commissioner Loke

WHEREAS

1. The majority of persons with disabilities are considered low income and depend on government funding and assistance.
2. Program and user fees at Vancouver community centres and recreational facilities do not currently reflect special fees and rates posted for persons with disabilities.
3. Many persons with disabilities require a care attendant to assist them when using community centres and recreational facilities. Although costs of user fees are discounted for attendants, the cost remains significant and is a burden for persons with disabilities, who are required to cover this cost.
4. Sports, Recreation, Arts and Culture have a huge impact on quality of life for persons with disabilities and access to community centres and recreational facilities promotes access to learning, skill building and socialization.
5. The cost of attending Vancouver community centres and recreational facilities is out of reach for some persons with disabilities and impedes their ability to participate in Sports, Recreation, Arts & Culture.
6. Currently, the user fees at community centres and Recreational facilities, impede accessibility for persons with disabilities.
7. Accessibility is identified in the strategic plan as an area the Vancouver Board of Parks and Recreation is working towards improving.

THEREFORE BE IT RESOLVE THAT the board direct staff to consult with the City of Vancouver Persons with Disabilities Advisory Committee and develop a strategy for persons with disabilities, to access Park Board community centres, recreational facilities and programs at a lower rate, similar to the rates offered to children and seniors;

THEREFORE BE IT FURTHER RESOLVED THAT the board direct staff to consult with the City of Vancouver Persons with Disabilities Advisory Committee to ensure Park Board addresses issues of physical accessibility to community centres, Recreational Facilities and Programs in Vancouver.

THEREFORE BE IT RESOLVED THAT the board direct staff to consult with the City of Vancouver Persons with Disabilities Advisory Committee to develop a strategy to reduce financial barriers at all Park Board facilities and programs for persons with disabilities including access exploring options such as, but not limited to, discounted rates offered to children and seniors.

### 3. Protecting Commercial Bicycle Rentals

WHEREAS

1. A robust cycling infrastructure is a key component of the City of Vancouver transportation plan;
2. Many bicycle rental businesses operate in Vancouver, particularly in the Stanley Park area and these businesses improve access and enjoyment of Public Parks;
3. The taxpayer subsidized Public Bike Share (PBS) network will significantly detract from the viability of the private rental sector.

THEREFORE BE IT RESOLVED THAT no PBS installations be placed near prominent tourist destinations specifically, but limited to, Stanley Park, the Vancouver Convention Centre and English Bay;

THEREFORE BE IT FURTHER RESOLVED THAT the PBS be installed at transit hubs only;

THEREFORE BE IT EVEN FURTHER RESOLVED THAT any PBS contract will require that no promotional memberships be offered at any time.
