- A. THAT the Vancouver Park Board enter into a CCDC 2

 Stipulated Price Contract (2008 edition) with JJM
 Construction Limited in the amount of \$698,500 plus
 GST, to be funded by the 2015-2018 Capital Plan, for the Vanier Park West Float and Launch Upgrade;
- B. FURTHER THAT the contract be on the terms and conditions outlined in this report, and on such other terms and conditions as are approved by the Vancouver Park Board, with Bid Committee and Chief Purchasing Official (CPO) concurrence;



- C. AND FURTHER THAT upon approval of the contract by Vancouver Park Board, with Bid Committee and Chief Purchasing Official (CPO) concurrence, the General Manager of the Park Board be authorized to execute the contract on behalf of the Board;
- D. AND FURTHER THAT no legal rights or obligations will be created by the Park Board's adoption of the above recommendations unless and until such contract is executed by the General Manager of the Vancouver Board of Parks and Recreation.



Progress to Date




- June 2015: hired JJM Construction Ltd to provide new east float –

- January 2016: obtained JJM Construction Ltd quote to provide west float, launch and breakwater enhancements – Phase 2




Existing Condition West Float, Launch and Breakwater
