Scope

- Recommends Park Board user fee changes effective 2017
- Aligns with calendar year and budget cycle: Jan 1st Dec 31st

Fee Change Recommendations

- Proposed increases of 2% for most areas
- Exceptions where fees will increase >2% will be discussed in more detail

Operating Budget Effect

 The planned fee increases have been factored into the 2017 proposed operating budget and will help offset 2017 cost increases by \$1.3M



- User fees will be levied to recover all or a portion of overall operating costs.
- All user fees will be adjusted to accommodate changes in the marketplace and in operating and maintenance costs.

Funds generated through user fees are utilized to recover a portion of overall operating costs, as well as to enable the Park Board to expand current services and offer additional services


Background

- Parking revenue subsidizes the operation of other parks and recreation programs and services
- The determination of parking rates is based primarily on pricing at nearby competing lots
- Park Board aims to keep parking prices reasonable so as not to inhibit users of Park Board facilities
- Last significant change to rates went into effect January 2014


Proposal

- New 7 day pricing model
 - Results in lower rate for Seniors & Youth on weekends/ holidays
- Rate increases:
 - Stanley Park and Queen Elizabeth ↑ \$0.65 to adult rates
 - Rupert Park ↑ \$0.90 to adult rates
 - Continue to offer free golf during winter season



Pitch and Putt – Rate Comparison





- VanDusen Gardens Proposed Rate Increases:
 - Regular seasonal admissions ↑2.0%
 - Festival of Lights ↑5.8%
 - Garden & room rentals ↑4.8%

Rationale:

- Investments have been made to enhance customer experience through interactive and engaging activities; added carousel ride for guests (included in admission)
- Admission will include a ticket to the Holiday Heights event at Bloedel

Promoting Online Sales:

- Offers savings and convenience vs. on-site purchase
- Last year, customers experienced 45-min line-ups for on-site ticket purchases.

Example:

On-site price (adult) : \$18.81 + GST = \$19.75On-line price (adult) : \$16.19 + GST + \$2.50 service fee = \$19.50



Proposal:

- Commercial rates ↑2% increase
- Charity/Non-Profit discount 37% off commercial rates




 Charity/Non-Profit discount was higher than general market practice resulting in rates lower than comparable facilities



Other Services – 2% Fee Increase or less







The proposed changes to user fees will result in \$1.3M of incremental revenue in 2017 to offset rising operating costs
