# **AGENDA ITEMS**

1. REPORT BACK: Youth Matters - Pledge, Guiding Principles and "Paige's Story"

Susie Hutchison, Manager of City-Wide Recreation, Park Board, introduced volunteers and members of the Ray-Cam Cooperative Community Centre and members of community groups in the audience.

Ms. Hutchison and Kate Hodgson, Centre Coordinator, Ray-Cam Cooperative Community Centre, jointly led the review of a presentation providing an update on the Park Board response to recommendations from the BC Representative for Children and Youth report, "Paige's Story" and highlighted:

- The reason for the call to action
- Purpose and principle of youth development initiatives in community centres

- Park Board is a funding partner of MoreSports, a program to increase participation and youth leadership through a city-wide network
- Responsible Indigenous Strategy for Empowerment (RISE) program
- Video on the RISE Aboriginal Life in Vancouver Enhancement Society (ALIVE) program (https://vimeo.com/137296590)
- Objectives of the partnership between ALIVE, Community Centre Associations (CCAs) and the Park Board
- Paige's story
- Key Park Board actions arising from the recommendations of the BC Representative for Children and Youth's report into Paige's death
- Youth Matters partners table
- Youth Matters Pledge of Support and Guiding Principles.

Ms. Hutchison, along with Ms. Hodgson, responded to questions from the Committee. There was discussion regarding the access to programming provided at the Ray-Cam Cooperative Community Centre, the community centres that currently lack a youth worker, whether there is support for the Youth Matters Pledge by CCAs across the system and the specifics of the duty to report.

Commissioners heard from six speakers. One speaker elaborated on Paige's story; three speakers offered ideas for the Park Board and community centres to advance reconciliation; and two speakers spoke on the positive personal impact of the RISE program and the Ray-Cam Cooperative Community Centre. The speakers responded to questions from the Commissioners.

## THAT the Vancouver Park Board:

- A. Receives, for information, staff's report back on the Park Board's progress made on implementing recommendations related to the City of Vancouver from the May 2015 report from the BC Representative for Children and Youth entitled Paige's Story: Abuse Indifference and a Young Life Discarded; and
- B. Endorses the Youth Matters Pledge of Support and Guiding Principles of Youth Matters Community Accountability, as described in Appendix A to the report.

Commissioner Mackinnon read aloud the full Youth Matters Pledge of Support and Guiding Principles of Youth Matters Community Accountability.

# **NEW BUSINESS**

Commissioners heard from a delegation that spoke in opposition to the Vancouver Aquarium's announcement that they would continue to keep cetaceans in captivity until 2029.

  - Consultation on the Clinton Park concept plan
  - Consultation on the renewal concept plan of Brewer's Park
- Park operations:

  - Development of overall Parks security plan with the assistance of corporate security
  - Activation of Andy Livingstone fieldhouse satellite Ranger station
- Commercial operations:
  - Burrard Marina upgrades

  - New Harbour Green restaurant site
  - Prospect Point Café restaurant renovation
  - Stanley Park Brewing development and construction
- Recreation:
  - Warming centres opened throughout January and February
  - Hillcrest Pool hosted the Provincial Eating Disorders Awareness Campaign Purple Pool Event on February 3, 2017
- Communication projects:
  - Social media metrics
- Business development and marketing
  - Success of the Flexipass promotion which ran from January 2 to February 7, 2017
- Special events:
