CHAIR'S REPORT

Chair Mackinnon highlighted the participation of Park Board Commissioners at events in the community that occurred in April and May 2018:

- Apr 28: Intertidal walk at Jericho Beach
- May 03: Celebration of planting 100,000 trees, a significant milestone towards the goal of

150,000 trees by 2020

May 06: Inaugural Vancouver International Little League Classic

May 06: BMO Vancouver International Marathon

May 11: Oakridge Park open house

May 12 Annual spring tree sale at Hillcrest Centre.

AGENDA ITEMS

1. UPDATE: Environmental Stewardship Update

Dave Hutch, Manager of Research and Planning, Park Board, introduced Dana McDonald, Environmental Stewardship Coordinator, Park Board.

Ms. McDonald led the review of a presentation providing an update on environmental stewardship and education activities in 2017 and 2018, highlighting:

- Park Board's stewardship initiatives
- Changing landscape of stewardship
- Park Board strategies for building stewardship:
 - Cultivating and maintaining partnerships
 - Supporting initiatives and innovation
 - Providing funding
- Examples of success in each of the strategies
- Stewardship opportunities
- Next steps.

Ms. McDonald, along with Howard Normann, Director of Park Operations, Park Board, Malcolm Bromley, General Manager, Park Board, and Mr. Hutch, responded to questions from the Committee. There was discussion on:

 Opportunities for partnering with the Vancouver Aquarium and Surfrider Foundation's Great Canadian Shoreline Clean-up activities; Georgia Strait Alliance's water testing and bird count projects; and City of Vancouver's Green Streets and Keep Vancouver Spectacular volunteer teams

Volunteers:

- Environmental Stewardship Coordinator's role in responding to and directing enquiries from potential volunteers
- Union acceptance of volunteer participation in park stewardship programs is generally dependent upon the amount and frequency of the work
- Request for information on the number of volunteers and results of volunteer work
- Need to clarify the process for potential volunteers to communicate with the Park Board
- Dog Park Stewardship Ambassadors Program:
 - Request for information regarding where the two Dog Park Stewardship Ambassadors will be active in summer 2018
 - Dog Park Stewardship Ambassador Program will be shaped on the basis of the experience and lessons learned from the summer 2018 pilot program
- Whether the costs of protecting parks from animals and invasive species is considered before embarking on measures

- Engagement with Community Centre Association (CCA) park committees in stewardship opportunities
- Consideration is being given to creating a "Friends of Park" movement to connect residents to their local park, modelled on the experience in Toronto
- Effectiveness of the Tree Guardians Program will be monitored during the summer 2018
- Opportunity to engage teachers during professional days that are currently being scheduled for the 2018/19 school year
- Opportunities to partner with the Vancouver School Board, "Friends of Park" movement and CCAs to augment resources allocated in the Park Board operating budget and capital plan
- Involvement of children's groups in park stewardship programs.
