## 1. REPORT: East Fraser Lands New Park - South Kinross - Contract Award

THAT the recommendation in the staff report be adopted on consent.

The following recommendation contained in the report was adopted on consent:

THAT the Board Committee recommend to the Board:

- A. THAT the Vancouver Board of Parks and Recreation ("Park Board") authorize staff to negotiate to the satisfaction of the Park Board's General Manager, the City of Vancouver's (the "City") Director of Legal Services, and the City's Chief Purchasing Official and enter into a contract with Cedar Crest Lands BC Ltd., for the construction of South Kinross Park, for a term of 1 year or until services are complete, with an estimated contract value of \$2,098,900.00, plus applicable taxes over the initial one year term, to be funded through the 2019 2022 capital plan;
- B. THAT the City's Director of Legal Services, Chief Purchasing Official and Park Board's General Manager be authorized to execute on behalf of the Park Board the contract contemplated by Recommendation A; and
- C. THAT no legal rights or obligations will be created by the Park Board's adoption of Recommendations A and B above unless and until such contract is executed by the authorized signatories of the City as set out in these Recommendations.

# 2. REPORT: East Fraser Lands New Park - Promontory - Contract Award

THAT the Board Committee recommend to the Board:

A. THAT the Vancouver Board of Parks and Recreation ("Park Board") authorize staff to negotiate to the satisfaction of the Park Board's General Manager and enter into a contract with Rust Investments Ltd., dba Shangri-La Landscaping, for the construction of the New Park in East Fraser Lands, for a term of one (1) year or until services are complete, with an estimated contract value of \$1,633,672.98 plus applicable taxes over the initial one (1) year term, to be funded through the 2019 - 2022 capital plan;

- B. THAT the Chief Purchasing Official and Park Board's General Manager be authorized to execute on behalf of the Park Board the contract contemplated by Recommendation A; and
- C. THAT no legal rights or obligations will be created by the Park Board's adoption of Recommendations A and B above unless and until such contract is executed by the authorized signatories of the City as set out in these Recommendations.

# 3. REPORT: Tatlow and Volunteer Parks Creek Daylighting - Construction Contract

Nicole Taddune, Senior Project Manager, introduced:

- Mandy Yu, Senior Landscape Architect, Park Board
- Max Scruton, Civil Engineer.

M. Yu led the review of a presentation on the proposed construction contract award for the Tatlow and Volunteer Parks Creek daylighting and highlighted:

- Background of the historic creek catchment area and the project
- Key objectives of the project
- Consultation with host First Nations
- Procurement process:
  - Summary of bids received
- Key dates.

M. Yu and M. Scruton, along with Dave Hutch, Director, Planning and Park Development, responded to questions from the Board Committee. There was discussion on:

- Confirmation that the contractor will be responsible for removing the invasive species on the site
- Whether there will be future opportunities for additional daylighting of the creek
- Concern regarding climate change resiliency
- Suggestion that the portion of Point Grey Road between Tatlow and Volunteer Parks be designated as park land to create a continuous park.

MOVED by Commissioner Demers SECONDED by Commissioner Irwin

THAT the Board Committee recommend to the Board:

A. THAT the Vancouver Board of Parks and Recreation ("Park Board") authorize staff to negotiate to the satisfaction of the Park Board's General Manager, the City of Vancouver's (the "City") Director of Legal Services, and the City's Chief Purchasing Official and enter into a contract with Wilco Civil Inc., the construction of Tatlow and Volunteer Parks Creek Daylighting, for a term of one year or until services are complete, with an estimated contract value of \$2,579,478.00, plus applicable taxes over the initial one year term, to be funded through the 2019 - 2022 capital plan;

- B. THAT the City's Chief Purchasing Official and Park Board's General Manager be authorized to execute on behalf of the Park Board the contract contemplated by Recommendation A; and
- C. THAT no legal rights or obligations will be created by the Park Board's adoption of Recommendations A and B above unless and until such contract is executed by the authorized signatories of the City as set out in these Recommendations.
