June 12, 2023	Public Engagement Timeline - Moberly Park Artificial Turf Field	Commissioner Viridi	Can staff provide a timetable regarding plans for the engagement process of Moberly Park Artificial Turf Field as it relates to the board motion titled "Prioritization of Sport and Recreation Fields and Facilities in Sunset Neighbourhood of South-East Vancouver"	<p>This work is in progress and staff will report back before the end of June with a Memo that provides Commissioners with an overview of the culturally appropriate engagement approach to address the Board's May 29th Motion to undertake a community engagement process of the Sunset neighbourhood that identifies the desired outdoor amenities by the community.</p> <p>Staff anticipate rolling out this engagement with a pop-up engagement booth at the July 1st - Canada Day event at Sunset Community Centre with a set of activities designed to learn about community needs and priorities for facilities.</p>
June 12, 2023	Stanley Park Waterworks Project - Update	Commissioner Haer	Can staff provide an update on the planned Metro Vancouver Water Infrastructure Repair Project in Stanley Park and when/if Metro Vancouver will be giving the Board a presentation on this project as previously requested.	This work is in progress and staff will report back on July 10 In-Camera, and July 17 in Committee for decision. Metro Vancouver will be providing a presentation on the project during the Committee meeting.
June 12, 2023	Harbour Green Dock Renewal - Reopening Timeline	Commissioner Haer	Can staff provide an update on the Harbour Green Dock renewal and the timing of its reopening.	The repairs to Harbour Green dock are complete, and Staff are finalizing the facility for re-opening during the week of June 26.
June 12, 2023	Air Force Garden of Remembrance Relocation - Update	Commissioner Howard	Can staff provide additional information on the status of relocating the Air Force Memorial Garden of Remembrance (AFGR) to Queen Elizabeth Park, as it relates to the previous Board decision in January 28, 2019?	<ul style="list-style-type: none"> - An Advisory Group was formed in January 2022 comprised of various stakeholders. Project was paused in March of 2022 due to difficulty in identifying a preferred location with primary stakeholders (Battle of Britain Memorial Fung/BBMF). Staff worked with primary stakeholders to identify a preferred site (Alternate Site #1) - Alternate Site #1 is located within Metro Vancouver Statutory Right of Way (SROW). Staff worked with Metro Vancouver to confirm support/approval and criteria for locating the AFGR within the SROW - In Jan 2023 staff received support and criteria from Metro Vancouver for working within MV's SROW - Staff reached out in Feb 2023 to primary stakeholder to confirm support of criteria for working within MV SROW. Park Board was informed that the primary stakeholder's lead contact was unable to be engaged in the first half of 2023. BBMF has recently reached out to PB staff to re-engage the project (June 2023) - Staff is reviewing capacity in terms of current Board priorities and Capital Plan delivery in terms of moving the project forward. Staff will reach out to BBMF once a path forward is confirmed
