STAFF REPORTS

1. Sponsorship and Sponsorship Naming Rights Policy

The Director of Business Services introduced the item and the Associate Director, Business Development presented an update on the Sponsorship and Sponsorship Naming Rights Policy. Staff responded to questions related to:

- Alignment with the United Nations Declaration of the Rights of Indigenous Peoples (UNDRIP)
- The requirement for naming rights agreements to be approved by the Board

THAT the Vancouver Park Board rescind the 2007 Naming Rights Policy, Park Board Community Facilities (the "2007 Naming Rights Policy"), attached as Appendix A to this report, and the 1995 Sponsorship Guidelines, (the "1995 Sponsorship Guidelines"), attached as Appendix B to this report. Also, that the Park Board approve the Sponsorship and Sponsorship Naming Rights Policy (the "2025 Sponsorship Policy"), attached as Appendix C to this report.
- B. THAT the Vancouver Park Board direct staff to implement the 2025 Sponsorship Policy, that is contained in Appendix C of this report.
- C. THAT subject to Recommendations A and B, the Park Board delegate standing authority: (1) to the Park Board General Manager to, in accordance with the 2025 Sponsorship and Sponsorship Naming Rights Policy, to negotiate agreements in

which the Park Board agrees to grant Sponsorship or Sponsorship Naming Rights to commercial parties with a value of up to \$3 million; and (2) for execution of such agreements, jointly to the Park Board General Manager and the City Solicitor.

D. THAT the Park Board delegate standing authority to the Park Board General Manager to, in accordance with the 2025 Sponsorship Policy, designate a staff member to negotiate, and execute agreements in which the Park Board agrees to grant Sponsorship rights for amounts less than \$50,000.

Volunteer Associations:

- 1.) The Board will consult with Community Centre Associations and other partners on aspects of sponsorship programs that might have an impact on their operations.
 - a. The Board agrees to consider a sponsorship request from an association if it in no way jeopardizes the Board's program.
 - b. There will be no aspect of a corporate sponsorship program affecting a community centre without the express approval of the relevant community centre association board. Such approval should be discussed within 30 days of notification by Park Board staff.
 - c. Corporate gifts and donations to community centres are outside of and unaffected by the corporate sponsorship program.
 - d. The Park Board will inform and notify key partners and rights holders on aspects of sponsorship and sponsorship naming initiatives that could have an impact on their operations.""

"The Park Board will consult community centre associations, key partners and rights holders on aspects of sponsorship and sponsorship naming initiatives that could have an impact on their operations."

THAT subject to Recommendations A and B, the Park Board delegate standing authority: (1) to the Park Board General Manager to, in accordance with the 2025 Sponsorship and Sponsorship Naming Rights Policy, to negotiate agreements in which the Park Board agrees to grant Sponsorship to commercial parties with a value of up to \$250,000; and (2) for execution of such agreements, jointly to the Park Board General Manager and the City Solicitor."

 - 1. Existing community centre names shall not be modified;

- 2. Existing stand-alone recreation facilities with neighbourhood names, including the Seawall, shall not be modified;
- 3. Staff shall prioritize sponsorship over naming rights; and
- 4. To the extent that naming rights are being considered, these shall emphasize events, and consider smaller units within existing facilities such as gyms or fitness rooms."

- A. The Vancouver Park Board hereby endorse the recommendation that the 17 parks listed in Appendix A be designated by Mayor and Council as Permanent Public Parks under Section 488(5) of the Vancouver Charter; and
- B. The Chair be directed to communicate this endorsement to the Mayor and Council forthwith.
