SUBJECT: Financial Statements - Operating and Capital Accounts

PURPOSE

Periodical financial reports are submitted to ensure the Board is kept fully informed of the current expenditures and revenues in relation to the approved budget appropriation.

DISCUSSION

Attached are financial statements for the Operating and Capital Accounts as of July 3, 1997.

1. Operating

As of July 3, 1997, 50.4% of the fiscal year has expired and 53.5% of the Basic Budget has been expended. The Administration and Planning divisions are reporting an unusually low expenditure level at \$917,386 or 37.9% of budget. This is due to the fact that the whole years budgeted charge to capital for its share of administrative costs has been processed (\$427,300). Other than this item, the overall expenditures and revenues reflect the normal historical operating position at this time of the year.

2. Capital

The statement of Capital Expenditures reflect the approved appropriations and expenditures for all of the active capital projects. When the projects are completed and their final costs reported, the appropriate accounts are formally closed and they are deleted from this statement. The 1997 approved portion of 1997-1999 Capital Plan funding has been added to the accounts.
