APPROVAL OF MINUTES

The minutes of the meeting of the Board held on Monday, September 28, 1998 were adopted as circulated.

CITY COUNCIL REPORT

Commissioner Warren reported on a report regarding the new Workers Compensation Act Bill 14 coming before City Council this week. This will create changes in the way the health and safety policy will be implemented and will result in greater responsibility and cost for the employer. The implementation date is yet to be announced by the Province of British Columbia.

With regard to the Capital Plan, Commissioner Warren stated that City staff have recommended that the next Capital Plan be for the period 2000-2002 so that the plebiscite will be held at the same time as the 1999 civic elections. This will result in a substantial saving as it would cost the taxpayers \$400,000 if there is a plebiscite held before the election. He further explained that the Capital Plan will go though various committees and a public information session in October 1999. As well, a report regarding the 1999

Operating Budget highlights a maximum increase in property taxes of 1.9%, reflecting a 1% increase related to increases in City expenditures and 0.9% relate to growth in the requisition from Greater Vancouver Sewerage and Drainage District. The expenditure reduction for the Park Board is \$367,000 if this is approved.

The General Manager clarified that the report is going forward to City Council with a proposal to target a 1.9% tax increase. However, if the Province reduces transfer payments to the City then taxes will have to be increased further or service level reductions will be much deeper.

Non Committee Report Item

2010 Olympic Bid

Mr. David Bentall, Venue Development, and Ms. Sandra Stevenson, President of Sport BC, and Board member of the Vancouver/Whistler 2010 Olympic Bid Society, provided an overview of the bid process and drawings of proposed venues at Hastings Park for Olympic events such as ice hockey and figure skating. These proposals would require renovation of the Pacific Coliseum and the Agradome.

Board members expressed concern regarding the parking requirements and whether the Agradome is designated as a heritage building.

Commissioner Chesman pointed out that since 1995 the Park Board have been working on a plan for Hastings Park which is being carried out now. He also noted that the Board has several arenas that require upgrading which could be used for Olympic events as well as the Vancouver Curling Club which also requires rehabilitation.

Moved by Commissioner Chesman,

THAT the Park Board expresses its enthusiastic support for the 2010 Vancouver/Whistler Olympic Bid on the following understandings:

- (i) THAT the bid shall have no negative impact on the Hastings Park Restoration Plan already unanimously approved by this Board and City Council;
- (ii) THAT the Committee and the Board will work together to locate appropriate amateur sports legacies for Vancouver;

- (iii) THAT the Board and the Committee will investigate current Park Board arena sites, or other sites, as possible venues for the 6,000 seat Olympic arena;
- (iv) THAT the Board and the Committee will work together to assess the potential of locating the Olympic curling venue at the current Vancouver Curling Club, or other sites;
- (v) THAT all of the above shall be sensitive and responsive to community concerns and desires.

- CARRIED UNANIMOUSLY".

It was agreed that a staff liaison will be appointed to work with the Vancouver Whistler 2010 Olympic Bid Society.
