**APPROVAL OF MINUTES**

The minutes of the meeting of the Board held on Monday, February 22, 1999 were adopted as circulated.

**CITY COUNCIL REPORT**

Commissioner Warren advised the Board that Council approved the Preliminary Budget estimates without further cuts, the final budget will be approved in April. An information report on the Vancouver Indy will be going to the Standing Committee on City Services and Budget on March 25<sup>th</sup>, 1999. Council also approved the 1999 moorage rate for an increase of 1.5% for Heather Marina.

**DELEGATIONS**

**Roundhouse Turntable Plaza Completion**

Board members received copies of a staff report dated March 12, 1999 recommending that the Board complete the development of the Roundhouse turntable plaza as outlined in the report.

Commissioner Fetherstonhaugh welcomed former Commissioner Evelyn

Atkinson. Ms. Atkinson asked the Board to accept the Roundhouse Community Arts and Recreation Society's recommendation to rehabilitate the Turntable using the capital funds provided by Concord Pacific Developments Ltd. It is important that the history of the 1800' s working turntable be saved and protected. Ms. Atkinson stated that she also appreciated the idea of maintaining the integrity of the Roundhouse turntable for future considerations. Ms. Atkinson extended her personal gratitude to Park Board staff for their expertise and co-operation with special mention to Jim Lowden, Svend Lojstrup and Rudy Roelofsen.

Board members discussed the matter and enquired how the space could be used for programming. Jim Lowden, Director of Stanley District advised the Board that there will be two small amphitheatres for various small group programming and when not in use for programming it could be a passive recreational space.

### **Vancouver General Hospital Open Space/Universal Gardens**

Board members received copies of a staff report dated March 12, 1999 recommending that the Board endorse the efforts of the Universal Gardens Society to establish a Universal Garden/Park at the Open Space to be created by the Vancouver General Hospital as part of it's redevelopment plan and that the Board reaffirms its support for the commitment to the existing Open space agreement under which the Vancouver General Hospital is to create 5.1 acres of Open Space to include the relocated existing tennis courts.

### **Community Centre Associations - Promotional Video**

The General Manager advised the Board that the video will give a high profile to the Park Board's services and its partnership with the Community Associations. Commissioner Yong asked if the video could be produced in various ethnic languages. Terri Clark, Public Affairs Manager advised the Board that a voice over could be done so that the video may be available in different languages.

### **Stanley Park Totem Pole Visitor Centre**

Jim Lowden, Director of Stanley District, reviewed the design for the Stanley Park Totem Pole Visitor Centre with the Board. One of the major components of the design is crowd management and creation of an interpretative centre for native culture.
