**APPROVAL OF MINUTES**

Minutes of the regular meeting of the Board held on Monday, July 30, 2001 were adopted as circulated.

**CHAIR'S REPORT**

1. City Council Report

City Council at it's regular meeting Tuesday, October 2, 2001 will be considering the report on coyotes. City Council approved the property acquisition for a combined Mount Pleasant Community Centre and Library.

2. The Chair read a statement concerning the events of September 11, 2001:

"The attack on the World Trade Centre in New York on September 11, 2001 left us all greatly saddened. Our sincere sympathies go out to all those here and around the world who have lost friends and relatives.

The Board of Parks and Recreation has always worked with and supported the inclusion of the diverse communities of Vancouver. This diversity of culture and faith is a strength which the Board highly values. As tensions around the world remain high, the Board reaffirms its commitment

to tolerance and peace, and, with its community centres and parks services, will work to ensure a safe and welcoming environment for all who live and work in our communities.” One minute of silence was observed.

The Chair advised the Board of a proposal called the Central Valley Greenway project. She explained the purpose of this project and the benefits to the community. She requested that the Board members do everything they can to encourage this proposal to be funded by VanCity.

## **STAFF REPORTS**

### **Coexisting with Coyotes in the Urban Environment**

Board members received copies of a staff report dated September 13, 2001 recommending that the Board approve recommendations A & C contained in the report.

Staff advised that the “Coexistence with Coyotes” strategy outlined in this report has been developed by the principal agencies working in the wildlife field in Vancouver. The strategy recognizes both the short term need to deal with problem wildlife and the longer term program of assisting residents of the City to understand the issues and find solutions to co-existence with the coyote. The continuation of these services is being recommended on a cost shared basis with City Council and includes representation from the agencies represented here tonight: Stanley Park Ecology Centre, and the Ministry of Water, Land and Air Protection.

Diane King appeared before the Board and outlined her support for the report and concerns regarding the threat that urban coyotes pose to family pets, children and their families.

**THAT the Board approve recommendations A & C of the Coexisting with Coyotes in the Urban Environment Report:**

#### **Recommendation A**

**That Council and the Park Board endorse a collaborative strategy in dealing with coyotes in the urban environment “Coexisting with Coyotes,” which includes public education and awareness programs, monitoring of coyote activities and responding to incidents involving aggressive animals. Discourage wildlife feeding, including coyotes, through public information and the increased enforcement of existing City and Park**

**Recommendation C**

**That the Park Board approve \$17,000 from the Corporate Sponsorship Fund for the increased production and distribution of brochures and education materials by the Stanley Park Ecology Society.**

**Communication Plan**

**VanDusen Botanical Gardens - Flower & Garden Show**

Staff advised that VanDusen's partners, the Vancouver Park Board and the VanDusen Botanical Gardens Association, have undertaken a strategic planning exercise resulting in a five year plan.
