CHAIR'S REPORT

Commissioner Jasper reported on the unveiling of Artist Jonathan Borofsky's work titled *Human Structures*, at Hinge Park as part of the 2014 - 2016 Vancouver Biennale; and on the ground-breaking ceremony to kick off reconstruction of the Little League Baseball diamonds at Hastings Community Park in preparation for the 2016 Canadian National Little League Championships.

AGENDA ITEMS

1. REPORT: Environmental Education and Stewardship Action Plan

Dave Hutch, Manager, Park Planning and Research, introduced members of the Environmental Education and Stewardship Task Force, and Lindsay Cole, Park Planner, presented the report and Action Plan. Mr. Hutch responded to a question.

- B. THAT the Vancouver Park Board direct staff to provide a status update on the progress made toward Environmental Education and Stewardship Action Plan (EESAP) implementation and key outcomes, and reconvene the Environmental Education and Stewardship Task Force at least once, within the next year.

MOTIONS

Motions on Notice

1. A Permanent, Structurally Safe Home for Love Locks

MOVED by Commissioner Coupar SECONDED by Commissioner De Genova

WHEREAS:

- 1. Vancouver City Council passed a resolution at the July 8, 2014 Regular Council meeting requesting that Councillor Affleck consult with the Park Board, the development community, Business Improvement Associations, and residents to find a permanent home for "love locks" in the city of Vancouver and report back to Council with an update;
- 2. Love locks are traditional padlocks that are attached to fences or railings by people to symbolize their commitment to each other;
- 3. Spontaneous, quirky activities are part of what makes Vancouver a great place to live:
- 4. The first Love locks in Vancouver were attached to the railings of the Burrard Bridge but were removed in 2013;
- 5. Love locks re-appeared on the seawall of Northeast False Creek where they have also recently been removed;
- 6. Removing love locks reinforces Vancouver's image as a "no-fun city"; and

7. A city is not just a collection of buildings and infrastructure;

THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Park Board Commissioners direct Staff to suggest possible locations for a permanent, structurally safe home for love locks on Park Board property and report back to the Board.
- B. THAT, once Staff have reported back on possible locations for a permanent, structurally safe home for love locks on Park Board property, the Park Board engage the public in a consultation process to determine the preferred, most favourable, and most feasible location to serve as a permanent home for love locks.

2. Bud Osborn - Recognition of Contributions

Commissioner Blyth introduced the following motion and showed a sample of Bud Osborn's poetry titled "Sunshine" (from the video clip: http://www.youtube.com/watch?v=3BGliSBvx84&feature=youtu.be)

WHEREAS:

- 1. Bud Osborn, a poet and social activist, passed away in Vancouver on May 6, 2014;
- 2. Bud Osborn was a founder of Vancouver Area Network of Drugs Users (VANDU), a group of users and former users who work to improve the lives of people who use illicit drugs through user-based peer support and education;
- 3. His work with VANDU helped lead to the creation of North America's first supervised injection site in Vancouver, and continued through legal challenges to laws affecting controlled substances and their users;
- 4. Bud Osborn's poetry and contributions led to a greater awareness and understanding of some of the struggle people live with in the DTES every day and he pushed to create change against the odds;

THEREFORE BE IT RESOLVED:

THAT the Vancouver Park Board staff work with family members and friends of Bud Osborn to create a memorial for Bud Osborn that people in the future can remember Bud's important contributions to Vancouver and the awareness he has helped to raise for people who need it the most.

- 5. A Board member enquired whether the boat ramp at Vanier Park would be completed for the Fireworks. The Deputy General Manager provided an update on the work being done to ensure completion.
