CHAIR'S REPORT

Commissioner Coupar reported on the following special events and activities:

- FIFA Fan Zone opened to the public at Larwill Park for fans to celebrate the Women's World Cup;

- during their training in the city, the FIFA Team Australia christened Empire Fields and met the public during a meet-and-greet held at Trillium Park;
- the FIFA Women's World Cup trophy tour stopped at Creekside Community Centre on May 28th;
- the FIFA Live Your Goals Festival was held at Trillium Park, encouraging young girls to develop their soccer skills;
- the Indian Consulate commemorated the 101st anniversary of Komagata Maru's arrival in Burrard Inlet, featuring government representatives, academics and artists;
- Khalsa Diwan Society Sports Festival's 50th anniversary celebration took place in May at Memorial South Park;
- Roedde House Museum's 25th anniversary celebration and garden party;
- Gathering Place Community Centre's 20th anniversary celebration;
- Windbreaks were installed at outdoor pools on May 21st; and

GENERAL MANAGER'S REPORT

Malcolm Bromley, General Manager, advised that Park Board related items at Council meetings that week included: a report on the City's Heritage Action Plan which also covers trees; a motion proposing 1000 new bike spaces, secure locking, and storage in the Downtown area; a report on the Hastings Park/Pacific National Exhibition Governance Review and By-law Update; Community Arts grants for 2015; a grant application toward funding the Killarney

Community Centre Energy Conservation Upgrade project; and a report of Community Benefits from Development.

The General Manager also reported that due to the heat wave in Vancouver, the Park Board is reviewing the timetable for opening of pools and water play facilities, and all Community Centres are designated "Cooling Centres" and will provide shelter from the heat.

1. Resident and Recreational Boaters Good Neighbour Campaign

WHEREAS:

1. The Park Board passed a Motion on April 27, 2015 to work towards improving Recreational Water Quality;
2. Vancouver Coastal Health (VCH) is erecting beach advisory signs in and around False Creek due to e-coli levels in the area, and intends to leave them up for the balance of the upcoming summer season;
3. Residents can help reduce impacts by not dumping chemicals in catch basins or down storm drains, cleaning up dog waste, and disposing of waste properly at regulated facilities;
4. Boaters can help reduce impacts by ensuring vessel waste is discharged at available pump-out stations;

- C. FURTHER THAT the plan be implemented as quickly as possible in advance of the busy summer recreational season.

1. **Governance of Hastings Park and elected Park Board representation on the PNE Board of Directors**

Commissioner Shum introduced a motion related to a report being considered by City Council at its Standing Committee meeting on June 10, 2015. The Chair outlined the history and advised of copies of the report titled "Hastings Park/Pacific National Exhibition Governance Review and By-Law Update" available.

SECONDED by Commissioner Crawford

WHEREAS:

1. The Vancouver Board of Parks and Recreation and its Commissioners are committed to the protection, stewardship and expansion of parks, gardens, and green spaces in the City of Vancouver, for the benefit of all citizens;
2. Vancouver City Council will be receiving a staff report entitled "Hastings Park/Pacific National Exhibition Governance Review and By-Law Update" at Council's Jun 10, 2015, Standing Committee on City Finance and Services. The report asks City Council to approve updated By-laws for the Pacific National Exhibition (PNE) that will serve to eliminate elected Park Board representation from the PNE Board of Directors and preclude elected Park Board oversight of Hastings Park;
3. The Vancouver Board of Parks and Recreation passed a unanimous motion at the Board's Monday, May 27, 2013 meeting calling for Hastings Park to be governed directly by the Park Board, as outlined in the Hastings Park Governance review, considering it to be the best option for achieving transparency and accountability in decision-making and increasing public access to the park's green spaces and recreational uses.
4. Hastings Park is historically the Park Board's second park, dating back to 1889 (just two years after Stanley Park was established), and was originally intended to be a premier destination park in the northeast corner of the city. Over many decades, the Park Board has been dedicated to re-establishing Hastings Park as a park site by adding green space including the Sanctuary, the Italian Garden, Plateau Park, and improving greenway connections throughout the site;
5. The lack of elected Park Board oversight for one of our city's largest parks represents a huge step backward and raises concerns about possible changes in direction at Hastings Park that could shift away from re-establishing Hastings Park as a premier destination park in the city;

THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Board of Parks and Recreation direct the Chair, on behalf of the Board, to write to Mayor Gregor Robertson and Vancouver City Council expressing the Park Board's deepest opposition to the elimination of an elected Park Board official from the composition of the PNE Board of Directors.
- B. THAT the Commissioners of the Vancouver Board of Parks and Recreation recommit to the view, previously articulated unanimously by Park Board Commissioners at the Board's Monday, May 27, 2013 meeting, that Park Board governance of Hastings Park is the best option for achieving transparency and accountability in decision-making and increasing public access to the park's green spaces and recreational uses, and that this view be conveyed in writing to Mayor Robertson and Council.

1. The Vancouver Board of Parks and Recreation and its Commissioners are committed to the protection, stewardship and expansion of parks, gardens, and green spaces in the City of Vancouver, for the benefit of all citizens;
2. Vancouver City Council will be receiving a staff report entitled "Hastings Park/Pacific National Exhibition Governance Review and By-Law Update" at Council's Jun 10, 2015, Standing Committee on City Finance and Services. The report asks City Council to approve updated By-laws for the Pacific National Exhibition (PNE) that will serve to eliminate elected Park Board representation from the PNE Board of Directors and preclude elected Park Board oversight of Hastings Park;
3. - B. THAT in this letter, the Vancouver Board of Parks and Recreation recommit to the view, previously articulated unanimously by Park Board Commissioners at the Board's May 27, 2013 meeting, that Park Board governance of Hastings Park is the best option for achieving transparency and accountability in decision-making and increasing public access to the park's green spaces and recreational uses.

ENQUIRIES

1. A Board member enquired about the current status of the Water Feasibility Study. The General Manager advised that this is being worked on by staff and a note would be sent to the Commissioner with a projected timeline.
2. A Board member asked whether Communications staff were able to exhibit the great work gardening staff are doing on the medians throughout Vancouver. The General Manager replied.
3. A Board member enquired about license requirements if someone is using a park as their studio. The General Manager advised that approval is required and there is a process.
4. A Board member enquired about the number of water bags around young street trees. The Chair noted 500 were placed in the first round.
5. A Board member requested an update on the management of chafer beetles. The General Manager will ask the Director of Parks to follow up with an update.
