- doors Open Vancouver took place on October 3, 2015, where the Park Board sold over 1,000 trees at deep discounts
- the construction of the Southeast Vancouver Seniors Centre was given the green light
- the Dunbar Village Business Association hosted its annual Harvest Festival on September 19, 2015
- the Nelson Park Community Garden has expanded to double the number of plots and gardeners
- the Vancouver Eastside 10K Run took place on September 19, 2015
- a fundraising gala, organized by the Thai Consulate-General, to support a school in Thailand was held on September 19, 2015

- the Chinese Benevolent Association of Vancouver and the Chinese Consul General celebrated the 66<sup>th</sup> anniversary of the People's Republic of China on September 16, 2015
- Queen Elizabeth Park's 75<sup>th</sup> anniversary celebration on September 13, 2015, was attended by almost 20,000 people
- appreciation was expressed to the Park Board urban forestry crew for their assistance in removing fallen trees and branches from city streets and sidewalks after the August 29, 2015, storm
- the City of Vancouver and Sport BC celebrated one year out from the multi-sport Americas Masters Games, which will come to Vancouver on August 26, 2016

- the Active Engagement and Integration Project, supporting the settlement, adaptation and integration of skilled workers from South Korea and Taiwan into Canadian society, was launched by S.U.C.C.E.S.S.
- the Botany of Beer class was held at VanDusen Garden on August 12, 2015
- the Thai Cuisine in the Garden event was held on August 13, 2015
- the Vancouver Park Board night at the Canadians took place on August 10, 2015

Michelle Collens, Manager, Sport Hosting Applications, City of Vancouver, spoke in support of the recommendation and responded to questions from the Committee.

Ty Speers, CEO, Tourism Vancouver, provided information on the benefits of hosting the IRONMAN 5i50 Vancouver Triathlon and responded to questions from the Committee.

The Committee heard from two triathletes, who were in support of the recommendation and responded to questions from the Committee.

- C. A road closure in Stanley Park from 5:30 am to 10:30 am on Sunday, July 10, 2016, to accommodate the cycling portion of the event.

# 3. **REPORT: McBride Park Improvements**

Tiina Mack, Manager of Park Development, Park Board, introduced:

- Lon LaClaire, Acting Director, Transportation Division, City of Vancouver
- Jason Hsieh, Planning Assistant, Park Board.

Ms. Mack reviewed the report on the proposed improvements to McBride Park and along with Ms. Hache and Mr. LaClaire, responded to concerns from the Committee regarding the recommendation to terminate discussions about the possible closure of Waterloo Street through McBride Park and questions on additional issues from the Committee.

The Committee heard from four speakers who were in support of the closure of Waterloo Street through McBride Park and one speaker who was opposed. The Committee also heard from one speaker who expressed support for the community garden. The speakers responded to questions from the Committee.

The Chair advised that a petition with 133 signatures in support of the closure of Waterloo Street to expand and connect the park was received by the General Manager's Office and had been distributed to Commissioners.

- C. THAT the Vancouver Park Board direct staff to terminate discussions about the possible closure of Waterloo Street between the eastern and western portions of McBride Park due to low public support.

#### GENERAL MANAGER'S REPORT

Malcolm Bromley, General Manager, reported on Park Board related items at the October 20, 2015 Vancouver City Council meeting:

- Minor amendment Pacific National Exhibition By-law regarding the remuneration and expenses of Directors
- Motion on Notice regarding the celebration plans for the 30<sup>th</sup> anniversary of Expo 86.

Mr. Bromley further advised that a celebration of life is being planned for Deputy General Manager, Huub Langeveld.

### MOTIONS ON NOTICE

The Chair announced that the movers of the Motions on Notice had consented to deferred consideration of the motions to the November 2, 2015 Park Board meeting.

### 1. Serving up a Fresh Concession Strategy

MOVED by Commissioner Kirby-Yung SECONDED by Commissioner Wiebe

THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Board of Parks and Recreation direct staff to explore other concession operating models and report back to the Board by the end of February 2016; and
- B. FURTHER THAT such initiative be broad in scope, giving consideration to: diverse business models; the repurposing of existing locations, possibly with modular facilities that could include new benefits such as movability, inclusion of eco-friendly water dispensaries, washrooms; and the introduction of new locations/concepts.

#### 2. Water Conservation Strategy

MOVED by Commissioner Wiebe SECONDED by Commissioner Mackinnon

THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Board of Parks and Recreation direct staff to report back to the Board on the costs and benefits of various measures that can be taken to mitigate against future droughts by reducing water use and conserving grey water; and
- B. FURTHER THAT the report be completed in time for measures to be included in the 2016 Park Board budget if necessary.

# 3. Providing More Parking for Bicycles & Vehicles Downtown

MOVED by Commissioner Shum SECONDED by Commissioner Wiebe

### THEREFORE BE IT RESOLVED

- A. THAT staff report back to the Vancouver Park Board, prior to public consultation, on the new Smithe and Richards park site, on the revenue generation, capital costs, and the park impacts associated with constructing and operating an underground vehicle and bicycle parking facility beneath the Smithe and Richards park location; and
- B. FURTHER THAT staff report on possible funding arrangements and partnerships available to the Park Board to construct and operate an underground vehicle and bicycle pay parking facility at the Smithe and Richards park site, including those that require no capital cost to the Park Board or to the City of Vancouver.

Note from clerk: Commissioner Shum submitted a revised version on this motion for discussion at the next meeting.

### NOTICE OF MOTIONS

#### 1. Public Consultations Standards Policy

Commissioner Crawford gave notice of motion on the following:

#### THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Park Board direct staff to prepare a presentation for Commissioners on current Park Board public consultation practices with a view to receiving input and direction from the Board on opportunities and ways to improve on current Park Board public consultation practices and processes;
- B. THAT following the staff presentation to the Board, and with due consideration to the input received from Commissioners, staff be directed to develop a Park Board Public Consultation Standards Policy for citizen input on Park Board projects and initiatives;
- C. THAT this Park Board Public Consultation Standards Policy be inclusive of any civic initiative that involves Park Board facilities and/or properties under the jurisdiction of the Park Board, regardless of, and independent of, whether such civic initiatives and public consultation processes are being coordinated by the Park Board or another partner organization; and
- D. FURTHER THAT staff be directed to deliver the presentation on existing public consultation practices to the Board, as noted in Part A above, by February 28, 2016, with a subsequent report back to the Board with recommendations for a new and comprehensive Park Board Public Consultation Standards Policy by the end of 2016.

# ENQUIRIES

- 1. A Board member reported that needles were found at Andy Livingston Park and requested an update on the maintenance at the park.
- 2. A Board member requested that the Park Board be informed of any impacts to the Cottonwood Community Garden and Strathcona Park, in the event that a decision is made to remove the Georgia and Dunsmuir Viaducts.
- 3. With regard to a previous motion passed, a Board member requested an update on the on the installation of a plaque in Stanley Park to commemorate aids victims.
- 4. A Board member recommended that a letter of congratulations be sent to the Prime Minister designate, with a reminder of the park investments required in Vancouver. Mr. Bromley advised that a letter would be drafted for the Chair's signature.
- 5. A Board member enquired about concerns expressed by the public regarding the Cyclocross race held in Vanier Park. Mr. Bromley reported that there was some damage to the turf and he is working with organizers to find a more suitable location to hold the event in the future.
- 6. With regard to a previous motion passed, a Board member noted the need to ensure that transgender signage is installed at community centres and sports facilities in a timely manner.
