ADOPTION OF MINUTES

1. Park Board Committee Meeting - February 22, 2016

AGENDA ITEMS

1. REPORT: 5th and Pine Pop-up Park - Concept Plan

Tiina Mack, Manager of Park Development, introduced Nick Page, Park Planning and Research, and Alexandre Man-Bourdon, Park Development.

Mr. Page led the review of the presentation and highlighted:

- the neighbourhood context and location of the pop-up park
- the project goals
- the elements of the draft concept plan that was presented to the public for comment
- the engagement process
- the revised concept plan developed in response to the input received during the public engagement
- sustainability features incorporated into the concept plan
- the proposed project schedule and budget.

Mr. Page, along with Malcolm Bromley, General Manager, Park Board, Ms. Mack and Mr. Man-Bourdon, responded to questions from the Committee.

MOVED by Commissioner Wiebe SECONDED by Commissioner Coupar

THAT the Committee recommend to the Board:

THAT the Vancouver Park Board approve the modified concept plan for a temporary ("pop up") neighbourhood park located on the southeast corner of West 5th Avenue and Pine Street.

2. REPORT: Reconciliation Art Program - Corporate Sponsorship Funding

Shauna Wilton, Acting Director of Recreation, introduced Jil Weaving, Coordinator, Arts, Culture and Recreation Engagement. Ms. Weaving led the review of the presentation and highlighted:

- the criteria for approval of use of Corporate Sponsorship funds
- the Park Board's Arts Policy

- progress on the Board's direction to implement the 11 reconciliation strategies which address the principles contained in the Truth and Reconciliation Commission's Calls to Action
- two reconciliation strategies require one time expenditures over and above the existing funding level in the operating budget:
 - \$15,000 for staff training on Indigenous issues and reconciliation
 - \$25,000 for a community-engaged reconciliation focused arts program.

Ms. Weaving, along with Malcolm Bromley, General Manager, and Ms. Wilton, responded to questions from the Committee. The Committee sought clarification on the participants and timing for the staff training and the adequacy of the funding being requested to provide the staff training.

The Committee heard from five speakers, all who spoke in support of the recommendation. One speaker advised of an Indigenous ceremony being planned for June 11, 2016 in Vancouver. Three speakers expressed concern that the funding requested for staff training is insufficient. One speaker recommended that the Park Board hire a full-time Aboriginal staff person to work with Ms. Weaving in the community-engaged reconciliation focused arts program. The speakers responded to questions from the Committee.

MOVED by Commissioner Evans SECONDED by Commissioner Coupar

THAT the Committee recommend to the Board:

THAT the Vancouver Park Board contribute \$40,000 from the Corporate Sponsorship Reserve for the implementation of two key Reconciliation strategies in response to the Truth and Reconciliation Commission of Canada's Calls to Action, including: staff training and the launch of the new Park Board Indigenous and non-Indigenous Community-Engaged Arts Program.

Amendment to the Main Motion

3. REPORT: Special Events Calendar 2016 - Major Events

Octavio Silva, Manager of Business Development, introduced Dave Rieberger, Supervisor of Special Events. Mr. Silva led the review of a presentation providing an update on the special events scheduled to occur over the coming year. Mr. Silva, along with Malcolm Bromley, General Manager, responded to questions from the Committee.

Staff undertook to advise Commissioners of the dates of major special upcoming events as they arise in order that they are able to engage in the events.

The Committee heard from one speaker who expressed concern regarding the impact to local residents as a result of the expansion of the number of events in Stanley Park, particularly private and corporate events that do not have a public benefit. Concern was also expressed regarding alcohol consumption at the events.

4. REPORT: RBC Run for the Kids - Special Event

Octavio Silva, Manager of Business Development, introduced Matthew Wright, Events Officer, BC Children's Hospital Foundation. Mr. Silva led the review of a presentation regarding the request for approval to hold the RBC Run for the Kids special event on June 5, 2016. This event was previously known as the Child Run. The organizers are seeking approval to relocate the start/finish area of the fun run route, where a festival would occur, due to the redevelopment in the area.

Mr. Silva responded to questions from the Committee. The Committee requested the organizers take steps to minimize the impact of the festival to the neighbouring residential areas.

MOVED by Commissioner Kirby-Yung SECONDED by Commissioner Evans

THAT the Vancouver Board of Parks and Recreation suspend the Park Board rules to allow the meeting to continue beyond 10:00 pm.

The Committee heard from one speaker who provided information about the needs of the BC Children's Hospital. The speaker responded to questions from the Committee.

The Committee requested that staff report back following the special event.

THAT the Committee recommend to the Board:

THAT the Vancouver Park Board approve a request from BC Children's Hospital Foundation to use Riley Park and adjacent spaces at Nat Bailey Stadium and Queen Elizabeth Park to deliver the RBC Run for the Kids event on Sunday, June 5, 2016.

The Committee adjourned at 10:03 pm.

STAFF REPORTS

GENERAL MANAGER'S REPORT

Malcolm Bromley, General Manager, advised that a report on Vancouver's celebration of Canada's 150th Anniversary would be provided at the March 8, 2016 Council meeting.

Other items of note are:

- a report to the Standing Committee of City Council on revisions to the Vancouver Sport Hosting Community Grant
- a report to the Standing Committee of City Council on 2016 moorage and other fees to be charged by the Heather Marina

a meeting with the World Wildlife Fund - Canada regarding potential partnerships on three projects.

The Board was advised that details of the City's announcement on the acquisition of the Arbutus Corridor would be discussed at an upcoming Board briefing.

MOTIONS ON NOTICE

1. Zero Waste - Diversion Stations

Commissioner Wiebe introduced the motion and commented on the need to place diversion stations at Park Board facilities to increase diversion rates.

MOVED by Commissioner Wiebe SECONDED by Commissioner Mackinnon

WHEREAS:

- 1. One of the City of Vancouver's 2020 Greenest City goals is to increase the diversion rate in Vancouver to over 70% by developing and implementing new strategies to remove organics/recyclables from the landfill;
- 2. A 2015 City Studio project demonstrated the need for diversion stations as their findings showed that currently there's one recycling bin per 30 garbage bins in the parks they surveyed, that the current bins move around which lead to missed pickups, recycling bins not beside garbage bins had high levels of contamination and little education/visual tools to help with diversion;
- 3. The Board of Parks and Recreation no longer deals directly with solid waste removal, as it is now the responsibility of The City of Vancouver's solid waste division;
- 4. The City of Vancouver's Healthy City Strategy states that people have the right to live in a healthy environment, with awareness of pollutants and contaminants that can cause harm; and
- 5. Metro Vancouver's current waste strategy includes diversion stations in all parks including dog waste.

THEREFORE BE IT RESOLVED THAT:

THAT the Vancouver Board of Parks and Recreation work with the City of Vancouver's Sanitation Operations, Real Estate and Facilities Management, all Community Centre Associations, and third-party businesses to create a diversion strategy that look at best practices which include: Metro Vancouver, the Vancouver Aquarium, and Granville Island to ensure that the Board of Parks and Recreation becomes a green leader in diversion and education.

Amendment to the Motion

MOVED by Commissioner Crawford SECONDED by Commissioner Kirby-Yung

THAT the resolution be amended to:

- A. THAT the Vancouver Park Board direct staff to work with Waste Management and Resource Recovery and Real Estate and Facilities Management at the City of Vancouver to develop an organics diversion strategy for Park Board parks and facilities, including a review of best practices at locations including, but not limited to, Metro Vancouver, the Vancouver Aquarium, and Granville Island;
- B. FURTHER THAT staff consult our Community Centre Association partners and third-party business partners operating at Park Board facilities on the potential implications of this strategy to their operating procedures;
- C. AND FURTHER THAT staff report back to the Board with the costs and resources associated with the implementation and administration of this strategy.

The Board discussed the proposed changes and upon seeking advice from staff, agreed to accept these changes as a friendly amendment to the original motion.

A. - C. AND FURTHER THAT staff report back to the Board with the costs and resources associated with the implementation and administration of this strategy.

THEREFORE BE IT RESOLVED THAT:

- A. The Vancouver Board of Parks and Recreation congratulate the City of Vancouver and Canadian Pacific Railway for reaching an agreement that allows the creation of the Arbutus Greenway;
- B. AND FURTHER THAT the Vancouver Board of Parks and Recreation seek a commitment from the City of Vancouver to make the creation of new parks in neighbourhoods underserved by green space along the new Greenway, a priority in decisions about how the Greenway is designed.

ENQUIRIES

- 1. A Board Member enquired if there are plans in place to send out crews earlier than scheduled to commence the spring clean up, following the mild winter. Howard Normann, Acting Director of Park Operations, advised that the change in scheduling is in progress.
- 2. In response to an enquiry from a Board Member, Mr. Bromley confirmed that the funding for the City's purchase of the Arbutus Corridor was not allocated from park acquisition funds.
