

■ Youth Development Initiative (2015)


- Citywide strategy that prioritizes community youth development
- Focus on leadership development and capacity building
- Enhanced access and inclusion for youth
- Establish and participate in youth service networks





Moresports

Moresports creates, facilitates and promotes recreation, sport and leadership development experiences for children and youth through a city-wide network of community partners.

Increased participation

- Thousands of children participating in Moresports
- 40.3% of participants were girls

2

Increased youth leadership

- 850 volunteer coaches
- 53% of coaches under the age of 19 are girls



3

City wide network

- 10 hubs (Vancouver + Coquitlam), 24 neighbourhoods
- 189 programs
- 17 different sports and physical activities

Responsible Indigenous Strategy for Empowerment (RISE)





- Community Centres are strategic **places** to launch reconciliation efforts; the well-being of individuals is closely tied to where they live and the quality of their neighbourhoods.
- Aboriginal youth leaders can help bridge the gap between Indigenous **People** and others in neighbourhood.
- Partnering in neighborhoods with a reconciliation vision can achieve **collective impact** through building new relationships and a culture of inclusion.




Paige's Story



“A drug overdose in April of 2013 was the direct cause of death for Paige, a 19-year-old Aboriginal girl living in Vancouver’s Downtown Eastside. But it was actually years of abuse and neglect, persistent inaction from front-line professionals and an indifferent social care system that led to this young woman’s demise.”



<p>Conduct urgent review of current provision of services to vulnerable children in DTES, informed by an accurate picture of their circumstances and the social services in this area.</p>	<p>Province of BC</p>	<p>Participate on three tiered Rapid Response Team (July 2015) to address service gaps and respond to vulnerable children and youth in DTES.</p>
<p>Analyze number of children in care, the needs of these children, and inventory of service providers in DTES and gaps in services.</p> <p>Creation and implementation of action plan, including detailed public reporting on outcomes for children and youth in DTES.</p>	<p>Province of BC</p>	<p>Ongoing participation in review, gap analysis, and action plan development for children who reside in or frequent DTES.</p>
<p>Provide training to staff working with children and youth on Duty to Report (Legal duty to report any suspected or disclosed child abuse or neglect).</p>	<p>COV, VPD, VPL, VFRS, PB</p>	<p>Park Board Community Youth Workers, core staff teams, and day camp staff trained on Duty to Report.
