## **AGENDA ITEMS**

# 1. REPORT: Exploring Park Board's Colonial Roots and Current Practices

Dave Hutch, Acting Director of Planning and Park Development, Park Board, introduced Rena Soutar, Reconciliation Planner, Park Board.

Ms. Soutar led the review of a presentation on a Colonial Audit to provide the Park Board with opportunities for new models of stewardship and equity, highlighting:

- Key drivers for colonial analysis
- Major areas of colonial impact:
  - Dispossession
  - Archaeology
  - Culture
  - Prioritizing non-Indigenous ways of knowing
- Rationale for undertaking a Colonial Audit.

Ms. Soutar responded to questions from the Committee. There was discussion on: expectation that future opportunities will unfold as the reconciliation work progresses; importance of engaging the public during the process; and the need to correct misunderstandings and undertake truth telling.

#### **Main Motion**

THAT the Committee recommend to the Board:

- A. THAT the Vancouver Board of Parks and Recreation receive and acknowledge the Initial Findings for a Park Board Colonial Audit, attached as Appendix A; and

# 2. REPORT: VanPlay – Parks and Recreation Inventory and Analysis and Goals

Dave Hutch, Acting Director of Planning and Park Development, Park Board, introduced the members of the VanPlay project team:

Messrs. Culbertson and Hutch and led the review of a presentation on the first two deliverables of the VanPlay – Parks and Recreation Services Master Plan project and highlighted:

- Background of the Park Board and previous Master Plans
- Project vision of "A new paradigm that will maximize access to high-quality parks and recreation experiences that connect people with themselves, each other and nature"
- Report 1 Inventory and analysis:
  - Consultation and document review processes

- Chapter 1 Introduction
- Chapter 2 Parks
- Chapter 3 Recreation
- Chapter 4 Facilities
- Chapter 5 Nature
- Survey assessing physical activity and how neighbourhood parks influence physical activity utilizing the System for Observing Play and Recreation in Communities (SOPARC)
- Park Provision study
- Report 2 10 Goals to Shape the Next 25 Years:
  - Document review and consultation processes
  - Draft goal 1 Grow and renew parks, community centres and other assets to keep pace with population growth and evolving needs
  - Draft goal 2 Protect existing parks and recreation spaces from loss, encroachment and densification
  - Draft goal 3 Prioritize the delivery of resources to where they are needed most
  - Draft goal 4 Focus on core responsibilities of the Park Board, and be a supportive ally to partners
  - Draft goal 5 Adapt our parks and recreation amenities to a changing climate
  - Draft goal 6 Create a green network that will connect our parks, waterfront and recreation areas
  - Draft goal 7 Restore Vancouver's wild spaces and vital biodiversity
  - Draft goal 8 Foster a system of parks and recreation spaces that are safe and welcoming to all
  - Draft goal 9 Seek truth as a foundation for reconciliation with Musqueam, Squamish and Tsleil-Waututh Nations
  - Draft goal 10 Secure adequate and ongoing funding for the repair, renewal and replacement of our aging parks and recreation system
- The final two components of the Master Plan will be delivered in 2019.

Mr. Hutch, along with Ms. Howard, Donnie Rosa, Director of Recreation, Park Board, and Mr. Culbertson, responded to questions from the Committee. There was discussion on:

- Process for the selection of the 24 parks for the SOPARC survey
- Suggestions:
  - Central Park and Pacific Spirit Park should be considered in the walkability analysis
  - Reconsider the wording of the project vision
  - Measure the utilization of sub-regions of destinations parks
  - Include an analysis on pools and ice rinks in Report 1 Inventory and Analysis
  - Incorporate the Park Board taking a leadership role in mitigating climate change and developing green infrastructure in draft goal 5
  - Specifically incorporate the elements of health, wellbeing and the promotion of sport into the draft goals
  - Reference the source of the baseline data included in Report 1 Inventory and Analysis

- Conduct the SOPARC survey during inclement weather to determine park usage during the winter months
- Need to gain an understanding of the threat posed to parks by invasive plants
- Importance of collaborating with the City to deliver several of the draft goals
- Whether draft goal 10 will be valid for the life of the Master Plan
- Need to consider the quality of park space in addition to the metric of walkability to parks
- Whether 25 years is an appropriate timeframe for draft goal 9, given the Park Board's desire to be a leader in reconciliation.

The Chair noted that Commissioners had received a copy of a memo on this item that a member of the public had sent to City Council.

THAT the Committee recommend to the Board:

- A. THAT the Vancouver Board of Parks and Recreation approve "Vancouver's Parks and Recreation: Inventory and Analysis", as outlined in this report and attached within Appendix A, to describe the current state of parks and recreation in Vancouver; and
- B. THAT the Board approve "Vancouver's Parks and Recreation; 10 Goals to shape the next 25 years", as outlined in this report and attached within Appendix B, to set guiding principles the future of parks and recreation in Vancouver.

Malcolm Bromley, General Manager, Park Board, reported on:

  - Free open-air concert at Sunset Park in collaboration with the Vancouver Symphony Orchestra on July 14, 2018
  - Blooming of the rare Titan Arum or Corpse Flower between July 15 and 17, 2018 led to over 10,640 guests visiting the Bloedel Conservatory

- Upcoming events:
  - Vancouver Mural Festival celebration concert at Jonathan Rogers Park on August 11, 2018
  - Participation in the 40<sup>th</sup> annual Vancouver Pride Parade on August 5, 2018
  - Inaugural Vancouver International Bird Festival from August 19–26, 2018
- Staff update:
  - Promotion of Dave Hutch to the position of Acting Director of Planning and Park Development
- Council will be receiving the following reports at the July 24, 2018 meeting:

#### **MOTIONS ON NOTICE**

# 1. Activating Community Space in Chinatown

The Chair reported that Commissioner Shum has withdrawn the notice of motion.

# 2. Learning from Children's Experience with Playgrounds

Commissioner Evans introduced the motion and noted that the purpose of the motion is to provide a mechanism to learn from and gather data to evaluate new playgrounds. Commissioner Evans responded to questions from the Board.

MOVED by Commissioner Evans SECONDED by Commissioner Shum

#### WHEREAS:

- 1. The Vancouver Board of Parks and Recreation is forecast to complete up to nine new or renewed playgrounds in 2018, at a cost of \$2.8 million;
- 2. Extensive community consultations were held with neighbourhood and other affected groups during the design phase of these playgrounds;
- 3. Many of these playgrounds reflect new trends in playground design including natural features and inclusive play areas;
- 4. In some cases, community groups including community centre associations have contributed funds to assist in the construction of these playgrounds; and
- 5. Post-construction evaluation and reporting on the experience of children using new playgrounds and new playground features is not a regular practice of the Park Board.

#### THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Board of Parks and Recreation implement a policy and practice of evaluating new playgrounds within one to two years of completion;
- B. THAT this evaluation include reports from children who use the playgrounds and their caregivers, as well as any community organizations that contributed to the construction costs; and
- C. THAT a summary report of these evaluations be published and provided to Park Board Commissioners and the general public on an annual basis.

# **Motion to Suspend Rules**

## **NOTICE OF MOTIONS**

 Recognition of Traditional Place Names within the Jurisdiction of the Vancouver Board of Parks and Recreation

Commissioner Mackinnon gave notice of motion on the following:

#### THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Board of Parks and Recreation work with the Musqueam, Squamish, and Tsleil-Waututh Nations on identifying the traditional names of places within the jurisdiction of the Park Board;
- B. THAT the use of traditional names be recognized by the Park Board; and
- C. THAT staff work with the Musqueam, Squamish, and Tsleil-Waututh Nations on ways to acknowledge those names at parks, beaches, and other public spaces within the jurisdiction of the Park Board, in a way deemed most appropriate by the Nations.

# 2. Ensuring Public Access to Privately-Owned Public Spaces ("POPS")

Commissioner Kirby-Yung gave notice of motion on the following:

# THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Park Board write a letter to Vancouver City Council in support of the Privately-Owned Public Spaces motion being brought forward to Council;
- B. THAT the Vancouver Park Board direct staff to identify a list of POPS sites that may be under its care;
- C. THAT the Vancouver Park Board explore steps to ensure sites under its care are welcoming and accessible to all including, but not limited to, signage; and
- D. THAT the Vancouver Park Board indicate its willingness to work with the City to extend its signage program to POPS as may be beneficial, in order convey these are public spaces.

# 3. Closing the Loop on Organic Waste in Stanley Park

Commissioner Wiebe gave notice of motion on the following:

THEREFORE BE IT RESOLVED THAT the Vancouver Board of Parks and Recreation direct staff to conduct a feasibility study on implementing a community composter in Stanley Park to create a closed loop waste management system for all organic materials produced within the park.

#### **ENQUIRIES**

- 1. A Board member enquired regarding the timing of the installation of the Park Board plaque on the new Killarney Seniors Centre. Donnie Rosa, Director of Recreation, Park Board, advised that the plaque has been ordered.
- 2. A Board member expressed concern that food trucks located at parks are blocking views and enquired regarding the Board approval process to allow food trucks to locate at parks. Malcolm Bromley, General Manager, Park Board, undertook to investigate.
- 3. A Board member enquired regarding the status of the renewal of the walkways at Roedde House, whether the adjacent area will be a public space maintained by the Park Board and the design and delivery of the park.
- 4. A Board member requested that staff investigate whether the lights hung by the Landmark Hotel display suite on Alberni Street are damaging the street trees.

There being no further business, the meeting was adjourned.
