## **STAFF REPORTS**

### **1. Golf in Vancouver Parks – Overview**

Joan Probert, Supervisor, Commercial Operations, Park Board, and Jeff MacLean, Supervisor of Golf Operations, Park Board, jointly led the review of a presentation on golf services and operations, provided in response to the Board's request for information, and highlighted:

- Previous reports provided to the Board
- High-level industry overview:
  - Variety of golf course formats and operations
  - Canadian participation in golf
  - Historic and predicted participation in golf in BC
  - Golf health and wellness benefits
- Park Board golf operations
- Environment and sustainability initiatives:
  - Green space naturalization and preservation
  - Water preservation
- Initiatives to increase participation in golf
- Planning and investment:
  - Golf Capital Reserve background and purpose
  - Integration of future planning with VanPlay
- Next steps.

Ms. Probert responded to questions from the Board. There was discussion on: net revenue derived from golf operations and utilization of annual surpluses; monitoring of the water quality on golf courses; ability to obtain detailed information on the “adult” demographic who play at Park Board golf courses; growth in golf participation since the decline following the boom of the 1990s; and water usage at Pitch and Putt golf courses.

Shauna Wilton, Deputy General Manager, Park Board, reported on:

  - Council received a report on “Vancouver Community Sports Hosting Grant – Fall 2019 Intake” at the October 22, 2019 Regular Council meeting
  - Council received a report on “Social Policy Grants for Neighbourhood and Non-Profit Capacity Building, Food Security and Social Innovation” at the October 22, 2019 Regular Council meeting, which included a recommendation to approve a grant of up to \$81,600 to the Strathcona Community Centre Association for their community breakfast program
  - The Standing Committee on Policy and Strategic Priorities will be discussing the motion referred by Council titled “A Collaborative and New Approach to Oppenheimer Park and Other Public Spaces” at its October 23, 2019 meeting

### **1. Collaborating with BC Housing on Homelessness in Parks**

Commissioner Dumont gave notice of motion on the following:

THEREFORE BE IT RESOLVED THAT the Vancouver Board of Parks and Recreation direct the General Manager to reach out to BC Housing with the goal of establishing inter-institutional knowledge-sharing and a relationship of direct, open communication regarding avenues of potential collaboration to address the impacts of homelessness in Vancouver parks.

## **ENQUIRIES**

1. A Board member asked why Park Rangers have been replaced by private security at Park Board meetings and whether there has been any feedback from union staff .
2. A Board member requested an update on when the special event branded banners and merchandise for the 50th Anniversary of Bloedel Conservatory would be available to the public.
3. A Board member sought information on the Park Board's policy regarding external agencies hiring private security to patrol Vancouver parks as there are reports on social media that the Commercial Drive Business Improvement Area (BIA) hired private security to patrol Grandview Park.
4. A Board member requested the plan and timetable for the replacement of trees removed on the 1100 block of Robson Street as well as an update on the overall tree replacement strategy for Robson Street that was initiated earlier this year with the Robson Street Business Association.
