



Park Board General Manager’s Office Report October 5, 2020

The following report is intended to provide an overview and update on recent and upcoming activities within the Park Board.

Riley Park Pavilion

Staff are currently in the process of developing a survey to seek feedback in response to a number of recent public enquiries regarding the proposed [Riley Park Pavilion](#), which was identified in the [Riley Hillcrest Master Plan](#) approved by the Board in 2014. This survey will be available in late fall on the new [Shape your City website](#), a citywide platform that allows residents to provide feedback on a variety of topics. Staff will update the Board as the process evolves.

Playground Renewals

Invitations to submit tenders for the playground renewals at Ash Park and Winona Park were posted on BC Bid on September 30, 2020. The contract awards for these two projects were included with a number of other playground renewal projects that were [pre-approved by the Board on July 8, 2019](#), however both projects were delayed due to staff changes and the impacts of COVID-19. Construction is now scheduled to begin in November, with completion expected in April 2021.

Ash Park Playground Renewal - The playground will feature new swings, slides, a play structure, and a wooden play hut. The safety surfacing will be a mix of play sand, engineered wood fiber and poured in place rubber.

Winona Park Playground Renewal - The playground will feature new swings, slides, trampoline, a spinning climbing net, spring rider, and a sand table. The safety surfacing will be a mix of play sand, engineered wood fiber and poured in place rubber.
