





10-Year Capital Strategic Outlook 2021-2030







10-Year Capital Strategic Outlook 2031-2040




Project Status: Consulting contract award expected end of 2020





Recommendation 4



Project Status: preliminary community outreach starting in November (public and urban indigenous engagement)



- A consulting **contract was recently awarded** by the City for delivery of the rezoning of the 18 acre site and a functional program of **Phase 1** (Building 1 – **pool**, recreation, childcare and non-market housing)
- The **functional program** will include detailed design criteria for the future pool and recreation spaces

Multiple Recommendations
for a comprehensive review



VanSplash Outdoor Pool Recommendations:

1. **Continue to invest** in the existing outdoor pools.
3. **Provide a balance** of recreation, fun, socializing, and fitness.
5. **Revitalize existing** outdoor pools (change rooms, mechanical equipment, etc.)
8. Conduct a feasibility study to **renovate Hillcrest Outdoor Pool to provide lane swimming**
9. Investigate the feasibility of operating (an) **outdoor pool(s) with extended season.**
10. **Provide a new outdoor pool** at Mount Pleasant Park.




Project Status: Site inventory, analysis, and project scoping including archeological, geotech, and cultural assessment are underway



Study scope includes:

- New outdoor pool in Mount Pleasant Park
- Renovate Hillcrest Outdoor Pool to add lane swimming
- Asses extended and/or all year around outdoor pool

Outcome of the study will include: Architectural, Mechanical schematic drawings, Class B costing for consideration for next capital plan





Project Status: Anticipating late 2020 consultancy start up

- The WEWMP process will **guide the siting** of the future Aquatic Centre and **integration** with the park, facility access, and parking and consider **existing Aquatic Centre site** as park space post-deconstruction.
- The facility's program development and design are not included within the master plan scope of work.



VAC Replacement Pool



About VAC:

- Unique structure that cannot be seismically reinforced - must completely replace concrete wall & roof panels
- Mechanical, electrical, and structural systems at end of life, dive tanks approaching end of life
- Does not meet current accessibility standards
- Produces highest GHG emissions from all City buildings




Beaches Recommendation 3



- Implemented the International Life Saving Federation (ILSF) Beach Safety Flags to establish the Supervised Swimming Areas
- Previously defined by wooden buoys attached to a chain
- Flags installed at each of the Vancouver guarded beaches in 2020 summer season.

Beaches Recommendation 5



- Board approved exploration of integrating rainwater management opportunities in John Hendry Park (VanPlay Implementation - One Water Initiatives approved Feb 10, 2020)
- Water quality improvement and technology investigations are on-going
- A second phase of public consultation for the draft master plan will take place in early 2021.

Innovation Recommendation 10



- New filter media was introduced at Hillcrest - Leisure Pool and at Kitsilano Community Centre - Whirlpool
- Improves water and air quality and lowers chlorine consumption
- It is planned that this type of filtration becomes a standard for Vancouver pools






