STAFF REPORTS

1. REPORT: Urban Forest Strategy Update

Amit Gandha, Director of Parks, Park Board, introduced Park Board staff:

- Chad Townsend, Senior Environment and Sustainability Planner
- Joe McLeod, City Arborist, Supervisor of Urban Forestry.

Messrs. McLeod and Townsend jointly led the review of a presentation on proposed updates to the Urban Forest Strategy and highlighted:

- Achievement of Greenest City 2020 goals for urban forest
- Targets identified in the 2018 Urban Forest Strategy
- Synergies with affiliated plans and strategies
- Urban forest equity and canopy deficient neighbourhoods identified in VanPlay
- The difference in the canopy cover measurements undertaken by LiDAR in 2013 and 2018
- Canopy cover by land type
- Canopy cover targets in Vancouver compared with selected other jurisdictions
- Proposal to establish a new urban forest canopy cover target of 30% by 2050
- Importance of urban forest for climate action
- Next steps
- Social and physical benefits of the urban forest habitat.

Messrs. McLeod and Townsend responded to questions from the Committee. There was discussion on:

- The amount of tree cover that would be required on private land in order to achieve the 30% target:
 - Initiatives that would be required to encourage private property owners to increase the number of trees
- Whether there is an opportunity to work with the Engineering Department to create areas to plant street trees in canopy deficient neighbourhoods
- Concern regarding the recent increase in tree mortality
- Suggestion that citizens be engaged to care for boulevard trees
- Concern regarding the capacity of the Langley tree farm to produce the variety of species of trees that will adapt to the changing climate:
 - Request that staff consider alternate sources of supply
- The rationale for selecting a canopy cover target of 30%, compared to the targets established by Portland and Toronto.

Recess

The meeting was recessed at 7:34 pm and reconvened at 7:40 pm.

The Committee heard from two speakers who provided the following comments and responded to questions from the Committee:

- Encouragement to increase the tree canopy in east Vancouver and in industrial areas
- Suggestion that the tree sales include trees with a larger canopy in order to increase the canopy
- The importance of continuous LiDAR surveys to measure the tree canopy
- Request for information on the cause of the recent increase in tree mortality

- B. THAT Park Board staff work with City of Vancouver staff to incorporate this new target into the Climate Change Emergency Response planning and land use policy work, and the pending Vancouver Plan; and

C. THAT staff report back on the implementation of the new canopy cover target on an annual basis.

The Committee unanimously agreed to adopt the recommendation in the staff report on consent:

THAT the Committee recommend to the Board:

A. THAT the Vancouver Park Board endorse the updated Vancouver Bird Strategy, as outlined in this report and attached as Appendix A; and

B. THAT the Vancouver Park Board direct staff to report back with revised Bird Friendly Landscape Operational Guidelines once they have been updated, in consultation with Park Operations staff and the Vancouver Bird Advisory Committee, to ensure they reflect the most effective bird friendly management practices in parks and other public open spaces.

3. REPORT: Park Board Procedure By-law Updates

Donnie Rosa, General Manger, Park Board, introduced Cheryl Chan, Manager, Executive Office and Board Relations, Park Board and Carol Lee, Meeting Clerk.

Ms. Chan led the review of a presentation on proposed updates to the Park Board Procedure By-law and highlighted:

- Background of the current Park Board Procedure By-law and the new City Procedure by-law
- Proposed amendments
- Additional considerations that would require a change to the Vancouver Charter and future Procedure By-law amendment:
 - Options to hold electronic meetings
 - Criteria for calling Special Meetings.

Ms. Chan responded to questions from the Committee. There was discussion on:

- Confirmation that the public currently is not permitted to speak on issues that are raised by Commissioners for inclusion on a Regular Meeting agenda
- Clarification on the process to seek changes to the Vancouver Charter and that criteria for Commissioners to attend meetings electronically would be brought back to the Board for approval first
- The Park Board Procedure By-law does not limit the frequency that two Commissioners or the Chair may call Special Meetings
- The provision allowing two Commissioner to call a Special Meeting has not been used extensively in the past.

Recess

The meeting was recessed at 8:33 pm and reconvened at 8:55 pm.

The Committee heard from 11 speakers, of which 10 spoke in opposition and one spoke in support of Items C and/or D of the staff recommendation. The speakers provided the following comments and responded to questions from the Committee:

- The need to accommodate the public who wish to address the Park Board
- The need for the Park Board Commissioners to face the electorate at in-person meetings
- The opinion that Items C and D of the staff recommendation are contrary to the democratic process and reduces public participation in Park Board meetings
- Suggestion that the majority of Commissioners be required to allow a Commissioner to attend a meeting electronically
- Request that digital recordings of meetings be preserved after they are deleted from the Park Board's website

Extension of Meeting

MOVED by Commissioner Coupar SECONDED by Commissioner Irwin

THAT the Park Board extends the meeting to 11:00 pm.

CARRIED UNANIMOUSLY

The Committee heard from three speakers who spoke in opposition to Items C and/or D of the staff recommendation. The speakers provided the following comments and responded to questions from the Committee:

- Suggestion that Commissioners be permitted to attend a meeting electronically if they are unable to attend in person and members of the public be permitted to attend a meeting electronically to provide comments
- Concern that the public is not permitted to speak to items that are raised by a Commissioner at a Regular Meeting
- Concern that requesting an amendment to the Vancouver Charter will provide the Province with an opportunity to abolish the Park Board.

Main Motion

MOVED by Commissioner Mackinnon SECONDED by Commissioner Dumont

THAT the Committee recommend to the Board:

- A. THAT the Vancouver Park Board approve, in principle, the repeal and replacement of the Park Board Procedure By-law, as set out in Appendix A of this report;
- B. THAT the Director of Legal Services be instructed to bring forward a by-law for enactment by the Board, generally in accordance with Appendix A;
- C. THAT staff be directed to seek a regulation, pursuant to the *Vancouver Charter*, to permit the Park Board to hold electronic meetings; and
- D. THAT staff be directed to seek an amendment to the *Vancouver Charter* to require Special meetings be called by the Chair, or upon request by a majority of Commissioners.

Amendment to the Main Motion

THAT Item D of the Main Motion be replaced with:

D. THAT staff be directed to report back with further information and recommendations on procedural option(s), in addition to or as an alternative to

- C. THAT staff be directed to seek a regulation, pursuant to the *Vancouver Charter*, to permit the Park Board to hold electronic meetings; and
- D. THAT staff be directed to report back with further information and recommendations on procedural option(s), in addition to or as an alternative to calling Special Meetings, to ensure that a minority of Commissioners have their motions considered and addressed by the public.

1. Climate Emergency Response, Green Operations, and Climate Change Adaptation Strategy

The Chair advised that this item is deferred to a future meeting as City staff who were originally scheduled to provide the presentation on December 7, 2020 are unavailable.

2. General Manager's Report

Donnie Rosa, General Manager, Park Board, reported on:

- Work on the RayCam Community Centre playground renewal is underway and is expected to be completed in Q4 2020
- The Charleson Park playground renewal has been completed
- Release of the first Vancouver Park Board Youth Stuff newsletter in November 2020 to over 200 subscribers
- Retirement of Alan Duncan, Environmental Planner, Park Board, in January 2021
- Items of interest to the Park Board to be considered at the December 8, 2020 Council meeting:
 - Report on 2021 Capital and Operating Budget, including a memorandum from the General Manager, Vancouver Board of Parks and Recreation, dated December 1, 2020
 - Report on Vancouver Bird Strategy Update and Implementation
- Board briefing memos and emails issued from November 30 to December 7, 2020.

MOTIONS ON NOTICE

1. Vancouver Aquatics Strategy and Blue Flag

Commissioner Demers introduced the motion and responded to questions from the Board.

MOVED by Commissioner Demers SECONDED by Commissioner Mackinnon

WHEREAS:

- 1. In May 2014, the Board approved a motion requesting staff to investigate the benefits of Blue Flag awards for Vancouver beaches and marinas; the subsequent report back from staff recommended Blue Flag to be "monitored for future consideration";
- 2. Blue Flag is the world's most-recognized award for clean, accessible, safe and enjoyable beaches. It is used in 46 countries. Blue Flags are awarded to beaches and marinas that meet high environmental, safety and cleanliness standards;
- 3. This Blue Flag initiative is an opportunity for Park Board to build on its current success, connect more people to water, and create lasting benefits for Vancouver's waterfront, tourism and small businesses;
- 4. With the support of a private funder, whereby all costs incurred in the process of applying for a Blue Flag award are covered, the Park Board can be the first to bring this prestigious award to British Columbia;
- 5. Swim Drink Fish is a registered Canadian charity established in 2001 that uses citizen science and communications technology to inspire people to know and safeguard local waters. In early 2020, Swim Drink Fish took over the National

Operator role and works with Blue Flag International to connect Canadian beach managers with other waterfront leaders from around the world;

- 6. A Blue Flag award would help the Park Board achieve its VanPlay Strategic Bold Moves, specifically to "protect and enhance the environment";
- 7. As noted in <u>VanPlay's</u> direction to Weave the City Together, the Approaches to Action contain a recommendation to "cultivate connection to nature through education, programming and stewardship" (N.4 Connection to Nature), with initiatives including:
 - N.4.1 Engage residents in fun and easy environmental monitoring, citizen science and environmental education programs to demonstrate the benefits of an ecological approach to horticulture and naturally managed spaces in parks;
 - N.4.2 Incorporate environmental education and interpretive signage into the park system in collaboration with Musqueam, Squamish and Tsleil-Waututh First Nations; and
 - N.4.3 Support environmental stewardship by providing expertise and resources, giving appreciation and recognition, and supplying training capacity building opportunities to community stewardship groups and environmental art projects;
- 8. As outlined in VanSplash, the 25-year strategy for aquatics in Vancouver, "recommendations for beaches place a particular emphasis on building on the current success of our beaches", including:

Recommendation 1: Consider activating or enhancing the range of aquatic experiences;

Recommendation 3: Invest in maintaining and enhancing existing beaches; and

Recommendation 4: Consider enhancing the diversity of experiences offered at/from the beach;

- 9. Blue Flag awards can provide an opportunity for the Park Board and Swim Drink Fish to collaborate on environmental monitoring, citizen science and environmental education programming:
 - a. Monitoring the water at Blue Flag beaches is a part of Blue Flag requirement. Swim Drink Fish's Vancouver Water Monitoring Program has already trained hundreds of citizen scientists;
 - b. Swim Drink Fish commits to lend its expertise in providing public water literacy workshops and education; and
 - c. Blue Flag information boards provide a tangible opportunity to appreciate and recognize participating community stewardship groups in collaboration with First Nations; and

10. Collection of required water quality data for five potential Blue Flag beaches (English Bay, Kitsilano Beach, Jericho Beach, Locarno Beach, and Spanish Banks) was completed in 2020. This data satisfies an important Blue Flag application requirement.

THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Park Board direct staff to complete one Blue Flag beach application by January 13, 2021; and
- B. FURTHER THAT a beach management committee is established and meet twice yearly.

THAT the motion be referred to staff to provide more information regarding the financial implications and the work required, including consultation with the First Nations.

The information should include data on cars and buses, and at least two years of pre pandemic data, 2018 and 2019, to establish baseline data.
- 2. A Board member requested a report from Easy Park on parking revenue and lot utilization, by parking lot as well as paid street parking, for all Park Board lots on Beach Avenue from the Vancouver Aquatic Centre to English Bay, including any data from recently installed electric vehicle charging stations in those lots. The information should include data on cars and buses, and at least two years of pre pandemic data, 2018 and 2019, to establish baseline data.
- 3. A Board member followed up on an enquiry from September 15, 2020 titled "Violent Incidents in Parks".

2. Election of Board Vice-Chair

The General Manager called for nominations for the Vice-Chair of the Board for 2021.

Commissioner Dumont moved, and Commissioner Irwin seconded, the nomination of Commissioner Demers as Vice-Chair of the Board for 2021.

Commissioner Demers accepted the nomination.

The General Manager called for additional nominations. There being no further nominations, the General Manager declared nominations for the Vice-Chair of the Board closed.

The General Manager announced Commissioner Demers elected as Vice-Chair of the Board by acclamation.
