



EXPLANATION

Parks Control By-law Amendment Regarding Liquor Consumption in Parks – Schedule 2

Enactment of the attached By-law will update Schedule 2 of the Parks Control By-law, which identifies the parks and areas within those parks that have been designated as places where liquor may be consumed during the Alcohol in Parks Pilot (Liquor Consumption in Parks Pilot).

Updates to Schedule 2 include revisions to the following seven (7) pilot site maps:

- a) Granville Park - squared-off east boundary along playground buffer for clarity.
- b) Memorial South Park - adjusted northeast boundary to minimize disturbance to recently planted young trees in that area; added wildlife buffer around western edge of the pond.
- c) New Brighton Park - adjusted western boundary, south of off-leash dog area, to remove section that will be a restoration area; adjusted northeast boundary to discourage use of pathway leading to environmentally sensitive area (salt marsh).
- d) Pandora Park - updated map image to reflect recent park renewal features; adjusted eastern boundary to remove area used as programming space, which is also frequented by families with young children (by spray park).
- e) Robson Park - squared-off southwest boundary along playground buffer for clarity.
- f) Vanier Park - added a 5-metre buffer around edge of freshwater pond to minimize disturbance to this ecologically sensitive area.
- g) Volunteer Park - removed yellow park boundary from Tatlow Park as it is not part of the pilot.

NOTE:

The revised pilot site maps reflect recommended boundary changes that were identified during development and review of the Alcohol in Parks Pilot implementation plan. Launch of the pilot is subject to the Liquor Control and Licensing Act amendments, outlined in Bill 8, Section 60, being put in force by the Province of BC.



A By-law to Amend the Parks Control By-law Regarding Liquor Consumption in Parks

THE BOARD OF PARKS AND RECREATION OF THE CITY OF VANCOUVER, in public meeting, enacts as follows:

1. This By-law amends the indicated provisions of the Parks Control By-law.
2. The Board repeals "Schedule 2 - Parks and Areas of Parks Where Liquor May be Consumed (Liquor Consumption in Parks Pilot Sites)", and replaces it with a new "Schedule 2 – Parks and Areas of Parks Where Liquor May be Consumed (Alcohol in Parks Pilot Sites)", as attached to this By-law.
3. This By-law is to come into force and take effect on the date of its enactment.
