- The percentage of rainwater that will be captured by the rain gardens will be determined during the design stage.

MEMBERS' MOTIONS

1. Signage for Safe Travel on Vancouver Park Pathways

Commissioner Barker introduced the motion and responded to questions from the Board.

Main Motion

MOVED by Commissioner Barker SECONDED by Commissioner Coupar

WHEREAS:

- 1. Vancouver has the world's longest uninterrupted waterfront path. The 28km Seaside Greenway is an uninterrupted pathway, including the Stanley Park Seawall, which extends from the Vancouver Convention Centre to Spanish Banks Park. Perfect for a walk, roll, cycle, or jog, it is the most popular recreational spot in the city;
- 2. The Seawall is divided into two clearly marked sections one for pedestrians and runners (closest to the water), and one for cyclists and all the other modes of transportation (inside path);

- 3. Pedestrians are located at the top of the City of Vancouver transportation pyramid as the highest priority;
- 4. Usage of Vancouver parks has increased during COVID-19 and information on how park pathways are used is key for the safety for all, with special notice to people with disabilities, compromised seniors, and small children;
- 5. In recent years, additional modes of wheeled transportation devices have been observed using the separated bike way on the seawall including, but not limited to, electric assist bikes, electric scooters, single wheel electric vehicles, and skateboards (including electric powered skateboards), many with a capability for high speed travel;
- 6. Further, due to the increased velocity of these new electric vehicles, they have the potential to cause serious injuries to other cyclists and pedestrians, especially those with mobility issues; and
- 7. Many signs and painted pavement markings are old and no longer visible.

THEREFORE BE IT RESOLVED:

- A. THAT Vancouver Park Board staff work with our City of Vancouver partners and report back on suggested measures to improve safety on the Seaside Greenway and all other park pathways, with emphasis on clear signage at pedestrian crossing points, speed reduction, and other engineering solutions, such as (but not limited to): improved signage; rumble strips to warn these vehicles of upcoming pedestrian crossing points; and a clearly posted seawall speed limit as deemed necessary to reduce vehicle pedestrian collision risk; and
- B. FURTHER THAT this report back be provided in time to begin safety improvements in the first quarter of 2022.

Amendment to the Main Motion

MOVED by Commissioner Giesbrecht SECONDED by Commissioner Mackinnon

THAT Item A be amended to read:

A. THAT Vancouver Park Board staff work with our City of Vancouver partners and report back on suggested measures to improve safety on the Seaside Greenway and all other park pathways, with emphasis on clear signage at crossing points, engineered solutions for speed reduction, such as (but not limited to): improved signage; rumble strips to warn these vehicles of upcoming pedestrian crossing points; and a clearly posted seawall speed limit as deemed necessary to increase user safety.

NOTICE OF MEMBERS' MOTIONS

1. Exploring Capital Funding for an Aboriginal Healing and Cultural Centre in CRAB Park

Commissioner Irwin gave notice of the following Member's Motion:

THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Park Board direct staff to seek clarity from the Vancouver Fraser Port Authority on the potential for a cultural healing centre to be permitted as a land use under the lease agreement for CRAB Park at Portside;
- B. THAT Park Board staff consult with the local First Nations (Musqueam, Squamish and Tsleil-Waututh) to confirm their desired level of involvement in a healing centre on the downtown waterfront;
- C. THAT, should the Vancouver Fraser Port Authority permit the use of land in CRAB Park for a cultural healing centre, Park Board staff work with City of Vancouver staff to request funding in the next capital budget (2022-2025) for a project definition phase (e.g. operator, program, capital, and operating budgets) for an aboriginal healing centre in CRAB Park, combined with an arts and cultural centre, in partnership with local First Nations (Musqueam, Squamish, and Tsleil-Waututh), urban indigenous residents, and the Union of British Columbia Indian Chiefs;
- D. THAT the Vancouver Park Board copy this request for capital funding to: Vancouver City Council, the federal Minister of Transportation, the local Member of Parliament, and the local Member of the Legislative Assembly.

OTHER BUSINESS

MOVED by Commissioner Giesbrecht SECONDED by Commissioner Dumont

THAT Commissioner Irwin be granted leave from on July 5, 2021 from 6:00 pm to 8:00 pm.

CARRIED UNANIMOUSLY

Commissioner Irwin encouraged all to fight against Sinophobia and racism against Indigenous peoples.

ENQUIRIES

1. A Board member enquired if there were any plans for additional swing sets to be added to Memorial Park South to meet current demand.

ADJOURNMENT

There being no further business, the meeting was adjourned.
