### Extreme Weather – Warming Centres





- The City, through ACCS, ensures all residents have a safe place to come inside during cold winter months and other extreme weather.
- The approach includes a variety of winter only responses including temporary Shelters, Extreme Weather Response (EWR) shelters and Warming Centres.
- Working with our CCA partner, West End Community Centre was identified as a Warming Centre to support this citywide response and activated December 24 to January 7.

## Extreme Weather—Ice Guarding & Monitoring






- Ice monitoring commenced December 26, 2021.
  Daily measurements taken until January 7, 2022.
- Ice Guarding was in place December 29, 2021 through January 7, 2022 at Lost Lagoon and Trout Lake.
- Ice thickness measured 4½ inches at the peak thickness. Ice needs to reach a thickness of 7 8 inches for safe public access.
- Lifeguards, Rangers and VPD were on site to provide education and direction reinforcing signage outlining the risk of going onto the partially frozen water bodies.

#### Extreme Weather - Park Board Events and Destination Parks



- Bright Nights in Stanley Park had derailments of trains, damaged equipment, resourcing issues and event closures due to extreme weather conditions.
- VanDusen Festival of Lights experienced closures due to burst pipes in the Visitor Centre and extreme winter weather. The Garden was also closed for ten days in January due to fallen and failed trees.
- Many trees at Queen Elizabeth Park have been largely impacted and Urban Forestry crews have prioritized maintenance of work to begin as soon as possible.
