D. Shearer led the review of a presentation on the proposed Vancouver Urban Food Forest in Burrard View Park (Food Forest) and highlighted:

- Background of Burrard View Park and the project
- Key elements of the proposed Food Forest
- Project timeline
- Alignment with VanPlay and Local Food System Action Plan (LFSAP)
- Technical analysis of the northwest and southeast site options
- Phase 2 public engagement that occurred in fall 2021:
  - Engagement approach and methodology
  - Input received
  - Challenges experienced during the engagement process
- Recommended option.

D. Shearer, along with C. Townsend, Dana McDonald, Environmental Stewardship Coordinator, Park Board, Amit Gandha, Director of Parks, Park Board, Donnie Rosa, General Manager, Park Board, and Amanda Gibbs, Engagement Manager, responded to questions from the Board Committee. There was discussion on:

- Comparison of the southeast and northwest sites with respect to:
  - VanPlay and LSAFP policy goals served
  - Accessibility
- Access to the fieldhouse for public use
- Request for information on the cost to improve the accessibility of the fieldhouse washrooms
- A large portion of the southeast site would continue to be available for unstructured children's play:
  - Whether a fence would be erected around the Food Forest to avoid conflict
- Other areas in Burrard View Park that would be available for children's unstructured play, with the erection of any required fencing, if the Food Forest were to be located on the southeast site
- The configuration of the siting options was identified by the proponent
- The contribution of the Food Forest to food security in the neighbourhood
- Whether the water supply from the Cottage Hospice could be utilized to service the northwest site

- Suggestion that the play area redevelopment include the use of the wading pool area for unstructured children’s play
- Suggestion to rectify the unauthorized off-leash dog use of Burrard View Park to increase the useable space in the park
- Whether engagement was undertaken with the children who utilize the southeast site.

3. Very experienced, capable Park Board staff may have their work contracted out; and
4. The Park Board gardeners and staff already maintain `green roofs` (Coal Harbour, Harbour Green Park).

#### THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Park Board have fully qualified Park Board staff maintain and carry-out all work for any future, or proposed `airspace` parks, similar to, but not including the new `airspace` park at Oakridge Centre Mall with the Westbank development, or in all parks that are in any way different from traditional, surface parks;
- B. THAT the Vancouver Park Board write management of the Oakridge development to request that Park Board staff be contracted to carry-out work in the new park at Oakridge Centre; and
