2. REPORT BACK: Seaside Greenway Proposal at Kitsilano Beach Park

Ian Stewart, Manager of Park Development, Park Board, introduced:

- Kevin Connery, Landscape Architect II, Park Board
- Kate McIntyre, Civil Engineer II (Acting), Park Board
- David Rawsthorne, Senior Transportation Engineer, City of Vancouver
- Paul Storer, Director Transportation Engineering, City of Vancouver.

K. McIntyre and K. Connery jointly led the review of a presentation on the proposed Seaside Greenway at Kitsilano Beach Park and highlighted:

- Project objective to find a location for a separated cycling path that links Balsam Street with McNicoll Avenue that creates a safe and more comfortable route for all park and Seaside Greenway users while reducing conflicts
- Context of the Seaside Greenway
- Existing Seaside Greenway in and adjacent to Kitsilano Beach Park
- Project background

- 2021 temporary safety improvements implemented
- Findings from the engagement undertaken from August 2021 to March 2022:
 - Round 1 engagement regarding values
 - Round 2 engagement regarding pathway alignment options
 - Round 3 engagement regarding the proposed pathway alignment
- Strengths and concerns and responses associated with each of the alignment options
- Costs and impacts of the proposed interim pathway.

K. Connery responded to questions from the Board Committee. There was discussion on:

- Request to correct the report to indicate that the creation of the cycle path was suspended in 2013 as a result of a court injunction and public concerns
- The number of parking spaces available near the Lift Restaurant where the cycle path would end
- Whether consultation was undertaken with Point Grey Hospital patients who utilize the existing multi-use pathway and are dependent upon mobility devices.

Recess

The meeting recessed at 7:18 pm and reconvened at 7:28 pm.

The Board Committee heard from three speakers, of which one spoke in support and one spoke in opposition to the staff recommendation; and one expressed opposition to Zone 1 while supporting Zones 2 and 3. The speakers responded to questions from the Board Committee.

- I. Stewart, K. McIntyre, A. Gandha and P. Fox jointly led the review of a presentation providing an update on extreme weather impacts and damages and highlighted:
- January 7, 2022 king tide and storm event
- Response and recovery process
- Overview of damage to:
 - Spanish Banks
 - Jericho Pier
 - Kitsilano Beach Park: Balsam to Trafalgar Streets
 - Vanier Park
 - Sunset Beach to Third Beach
 - Third Beach to Prospect Point
 - Stanley Park Seawall Third Beach to Prospect Point
- Debris removal from beaches and the Stanley Park Seawall

- Damage to the Kitsilano Pool and seawall:
 - Multi-disciplinary assessment has commenced
 - Next steps
- Order of magnitude cost estimates for repair work
- Coastal adaptation planning process.
- I. Stewart responded to questions from the Board. There was discussion on:
- The possibility of expanding the scope of the West End Waterfront Master Plan to include areas north of Third Beach
- The potential to reopen a portion of the Vanier Dock for the summer boating season
- Funding available from senior governments
- Whether measures will be put in place to prevent damage from hazards, such as barges, in the future.

2. General Manager's Report

Members of the Park Board Senior Leadership Team presented the General Manager's Report and highlighted:

- Introduction of Betty Lepps, Director of Urban Relationships
- Discounted admission to Playland has been added to the Leisure Access Program
- Expectation that the Oppenheimer Park fieldhouse and playground will reopen by the end of April 2022
- Reminders not to release, touch or feed Jericho Beach rabbits, which are an invasive species
- Upcoming Council business related to or impacting parks and recreation:
 - Report on Wildlife Feeding Regulation
- Board briefing memos and emails issued from March 28 to April 11, 2022.

B. Lepps was invited to share a few words on the first day of her employment with the Park Board.

It was suggested that the Park Board explore opportunities to partner with other organizations to expand the Leisure Access Program.

MEMBERS' MOTIONS

1. Bloedel Conservatory Visitor Centre – Feasibility and Funding

Commissioner Coupar introduced the motion and responded to questions from the Board.

Main Motion

MOVED by Commissioner Coupar SECONDED by Commissioner Mackinnon

WHEREAS:

- 1. The Vancouver Park Board manages the iconic Bloedel Conservatory at the pinnacle of Vancouver with the Vancouver Botanical Garden Association (VBGA) and has done so since 2012;
- 2. There has been an identified need to expand the Conservatory's footprint to include a visitor centre containing classrooms, gift shop, and food services; this need was confirmed in the joint business plan of 2011 and at a VBGA strategic planning session in November 2018; past VBGA Board motions also support the need for a new visitor centre, including formally indicating to the Park Board that they were prepared to contribute \$50,000 toward a feasibility study;
- 3. In March 2019, the VBGA President indicated the VBGA Board was prepared to fund a portable option as proof of concept and was prepared to tender a contract to purchase. In July 2019, in support of Bloedel Conservatory's 50th anniversary, the Park Board approved a motion directing staff to explore the feasibility of allocating up to \$150,000 from the operating budget to provide a portable for the VBGA to do public education at Bloedel; staff indicated in the feasibility report back that although it was not possible to provide a facility for the 50th anniversary celebrations, staff would continue to work with the VBGA toward the goal of increased programming capacity for Bloedel Conservatory;
- In the book "The Jewel atop Vancouver: 50 years at the Bloedel Conservatory", published to commemorate the 50th anniversary and signed by Stephen Shapiro, the Executive Director of VBGA, the VBGA has signalled that improvements can be made through investments from both donors and taxpayers alike in building a state-of-the-art Visitor Centre that includes: a new admissions and information desk; an airlock door for better temperature control; a classroom to deliver and expand on world class education programming; and a café with food service for guests to enjoy refreshments. Continued investment in the collections will ensure endangered plant species can be saved and cultivated in the Conservatory's environment. Since then, the VBGA has discussed plans to raise up to 5 million dollars in support of this new addition; and
- 5. The Park Board will soon be deciding on Capital funding priorities for the upcoming 4 year Capital Plan, and almost 10 years have passed since the need for a new Visitor Centre was identified in the joint business plan.

THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Park Board accept the offer of \$50,000 from the Vancouver Botanical Garden Association (VBGA) toward funding a feasibility study for a new Visitor Centre at the Bloedel Conservatory, and direct staff to immediately begin work on this study;
- B. FURTHER THAT this feasibility study be carried out concurrently with the ongoing work on the Queen Elizabeth Park Master Plan; and
- C. THAT staff report back with the study findings and recommendations for next steps.
