STAFF REPORTS

1. REPORT: Carnaval del Sol – Special Event

Octavio Silva, Manager, Business Development, Park Board, introduced Yuna Flewin, Filming and Events Officer, Park Board.

O. Silva led the review of a presentation on the proposed Carnaval del Sol special event and highlighted:

- Background on the event organizer, Latincouver Cultural and Business Society
- Event objective to promote and showcase Latin American arts and culture
- History of the event in Vancouver
- Proposal to host the event at Jonathan Rogers Park in July 2022
- Preliminary site plan
- Key event parameters
- Other considerations and next steps.
- O. Silva responded to questions from the Board Committee. There was discussion on:
- Confirmation that the facility has the capacity to accommodate the anticipated number of guests over the three-day event period
- Whether a site-wide liquor license has been considered by the event organizer.

Recess

The Board Committee heard from three speakers, all of whom spoke in support of the staff recommendation. The speakers responded to questions from the Board Committee.

THAT the Vancouver Park Board approve an application from the Latincouver Cultural & Business Society ("Latincouver") to host Carnaval del Sol at Jonathan Rogers Park on Friday, July 8, 2022, from 6:00 to 10:00pm, Saturday, July 9, 2022, from 12:00pm to 10:00pm, and Sunday, July 10, 2022, from 12:00pm to 9:00pm, with all arrangements to the satisfaction of the General Manager of the Park Board: and

B. FURTHER THAT the Park Board approve an application from Latincouver for an all ages Special Event Permit from the BC Liquor & Cannabis Regulation Branch to serve alcohol at the aforementioned location and dates, with a maximum capacity of 1,500 guests.

2. REPORT: Musqueam, Squamish and Tsleil-Waututh (MST) Flags at Brockton Point

Rena Soutar, Manager, Decolonization, Arts and Culture, Park Board, introduced Emily Dunlop, Senior Planner, Planning, Policy and Environment, Park Board.

E. Dunlop led the review of a presentation on the proposal to install MST flags on the recently replaced flagpoles at Brockton Point in Stanley Park and highlighted:

- Decolonization mission, vision and values approved by the Board
- Historic MST presence in Stanley Park
- Various flags currently located in Stanley Park
- The previously planned flag raising ceremony was delayed due to the COVID-19 pandemic.
- R. Soutar responded to the suggestion to place informational signage in the vicinity of the newly raised flags.

THAT the Board Committee recommend to the Board:

THAT the Vancouver Park Board approve the installation and raising of Musqueam, Squamish and Tsleil-Waututh flags on the newly replaced flagpoles at Brockton Point in Stanley Park.

- L. Todd led the review of a presentation on the Community Centre Strategy and highlighted:
- Purpose of the Community Centre Strategy
- Community centre planning and development process

- Service is delivered jointly with Community Centre Associations (CCAs)
- Project timeline and process
- Reports that informed the development of the Community Centre Strategy
- Service target categories:
 - Foundational service targets
 - Planning service targets
 - System-wide service targets
- Prioritization principles and criteria:
 - Quality infrastructure
 - Equitable and inclusive infrastructure for all
 - Demonstrated service need
 - Efficient use of land resources
- Community centre prioritized renewal list
- Process for individual community centre planning
- Financial considerations:
 - Current (2019 2022 capital plan)
 - Roughly 30 years would be required to complete the 11 projects on the prioritized renewal list
- Next steps.
- L. Todd, along with K. Perkins, B. Johnston, S. Slawuta and D. Hutch, responded to questions from the Board Committee. There was discussion on:
- Concern that the older community centres that are lower on the prioritized renewal list will be unusable before they are renewed:
 - The prioritization will be revisited if additional capital funds become available
 - Work is ongoing with Real Estate and Facilities Management (REFM) to maintain and repair the community centres to ensure they do not become unusable
- The prioritized renewal list was presented to and supported by the Community Centre Associations (CCAs)
- Concerns with the seismic condition of community centres
- Request for the seismic reports prepared for the community centres
- Whether senior government funding is available to the Park Board to perform the seismic upgrading
- Request for information on the community centres that have received seismic upgrading in the last five years
- Whether the anticipated number of seniors in the neighbourhoods in the next five years were considered in the development of the prioritized renewal list

 Whether upgrades, expansion and renewals are eligible uses of Community Amenity Contributions (CACs) and Development Cost Levies (DCLs).

NOTICE OF MEMBERS' MOTIONS

1. Preserving Green Space in the Grandview Cut

Commissioner Giesbrecht gave notice of motion on the following:

THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Park Board communicate to the City of Vancouver its concerns about the climate, bird habitat, forest canopy, connectivity, and cultural impacts of the proposed redevelopment of the Safeway site at 1780 East Broadway; especially the impacts of the proposed ramps through the Grandview Cut, and request that the City direct the applicant to relocate or redesign the proposed access points to the development to mitigate these impacts; and
- B. FURTHER THAT the Park Board support preserving the publicly owned Grandview Cut and its ecological and community benefits from further encroachments associated with future adjacent redevelopments along the length of these City lands.

OTHER BUSINESS

Commissioner Coupar reported on the ceremony held on April 14, 2022 to mark the passing of Capt. Steve Letourneau, a dedicated Vancouver Fire and Rescue Service member who died from cancer in 2020 after being exposed to chemicals while on the job.
