- Two expressed concerns with the lack of representation in studies and workshops.

## **STAFF REPORTS**

### **1. REPORT: Park Board Code of Conduct Policy**

John Brodie, Acting Director, Strategic Operations and Board Relations, Park Board, introduced.

- Andrew Aguilar, Lawyer, City of Vancouver
- Jason Twa, Assistant Director, Civil Litigation, City of Vancouver.

A. Aguilar led the review of a presentation on the proposed Code of Conduct Policy and highlighted:

- History of the City’s Code of Conduct By-Law

- The City’s Code of Conduct Policy does not apply to Commissioners or Park Board Advisory Board members
- Recommendation that a Code of Conduct be in the form of a policy passed by resolution of the Park Board
- Key provisions of the proposed Code of Conduct Policy
- Complaint and resolution procedures
- Changes from the City by-law
- Requirements for a mandatory review
- Code of Conduct principles
- Next steps.

A. Aguilar, along with J. Twa, responded to questions from the Board Committee. There was discussion on:

- Concern regarding the Integrity Commissioner’s interpretation of the principle of demonstrating collaboration with respect to the public expression of dissenting views from the majority of Commissioners
- Suggestion to include definitions in the Code of Conduct Policy of the terms “leadership” and “collaboration” to avoid future disagreement:
  - The Code of Conduct Policy would utilize the Province’s and City’s definition of “collaboration” and “leadership”, respectively
- Concern that the principle of “collaboration” would prevent the expression of dissenting views.

The Board Committee heard from two speakers. One speaker expressed opposition to the proposed Code of Conduct Policy and one speaker noted issues with the Park Board’s implementation of policies.

**5. REPORT: Stanley Park Mobility Study – Initial Findings and Directions**

Emily Dunlop, Planner II, Park Board, and Nalon Smith, Planner II, Park Board, jointly led the review of a presentation on the purpose, scope and initial findings of the Stanley Park Mobility Study (Mobility Study) and highlighted:

- Project overview, scope and timeline
- Goal of the Mobility Study is to improve park access and the user experience for all, by developing and evaluating the feasibility of options for the reduction in private vehicle traffic
- Public and stakeholder engagement:
  - Lessons learned from previous public engagement
  - Mobility Study engagement process, timelines and participation
  - Key themes that emerged from listening sessions
- Key lessons learned from best practice and case study review
- Mobility data collection and analysis:
  - Total annual visitation by mode from 2017 to 2021
  - Total visitors vs. park vehicle entries from 1980 to 2020
  - Barriers to using transit
  - Opportunities and challenges of reducing vehicle traffic in Stanley Park
  - Transportation mode share over time
- Foundational values to be explored as part of the Mobility Study:
  - Reconciliation
  - Equity
- Values, priorities and key themes that emerged from stakeholder engagement

- Guiding Principles developed through public and stakeholder engagement:
  - Safety
  - Accessibility
  - Economic vitality
  - Climate action and environmental protection
  - A flexible and resilient system
  - A connected transportation network
  - Enhance park experience
- Next steps.

E. Dunlop, along with Amanda Gibbs, Senior Manager, Communications, Marketing and Engagement, Park Board, Simon Mueller, Senior Transportation Planner, Mott MacDonald, Donnie Rosa, General Manager, Park Board, and Dave Hutch, Director, Planning and Park Development, Park Board, responded to questions from the Board Committee. There was discussion on:

- Concern with the small representation of visitors to Stanley Park who responded to the survey
- Whether the survey included question about the amenities visited in Stanley Park, as opposed to the area
- The reasons for the significant reduction in daily traffic entering Stanley Park from 1980 to 1990
- Confirmation that the Guiding Principles are not listed in priority order
- Confirmation that the 1908 lease agreement with the federal government, which includes provisions regarding the use of the perimeter road around Stanley Park, will be included in the final report to be provided to the Board in spring 2023:
  - Whether changes have been made to Stanley Park Drive have been approved by the federal government
- Local First Nations did not indicate their preferred mode to access Stanley Park during the consultation
- Sources of historical data included in the Mobility Study.

The Board Committee heard from three speakers, of which one spoke in support and two spoke in opposition to the staff recommendation. The speakers responded to questions from the Board Committee:

### **Meeting Reconvened**

The Chair reconvened the Board Committee meeting of the Vancouver Board of Parks and Recreation on Tuesday, July 19, 2022 at 6:35 pm.

The Board Committee heard from 12 speakers, of which 3 spoke in support and 9 in opposition to the staff recommendation. The speakers provided the following comments and responded to questions from the Board Committee:

- Agreement with Guiding Principle of accessibility
- It is premature to proceed with the Mobility Study when the complaint lodged with the BC Human Rights Tribunal has not been decided
- Request that the scope of the Mobility Study be expanded to include the 32 km gravel road network within the park
- Concern with the lack of consultation with the cycling community regarding the planned closure of 83% of the gravel roads within Stanley Park to cyclists
- The need to balance the concepts in the Mobility Study with the critical transportation routes required to hold live events in Stanley Park, particularly those at Brockton Point
- Concern with the Park Board voting on draft Guiding Principles of an incomplete study that does not have a defined goal
- The need to protect and prioritize the accessibility rights of people with disabilities
- Concern that the increase in parking rates has resulted in a reduction in the number of park visitors
- Concern with the accuracy of the statistics in the Mobility Study regarding the percentage of the Vancouver population with disabilities.

### **Recess**

The meeting recessed at 8:12 pm and reconvened at 8:25 pm.

The Board Committee heard from 22 speakers, of which 10 spoke in support and 11 in opposition to the staff recommendation. The speakers provided the following comments and responded to questions from the Board Committee:

- The opinion that the safety of the park and park experience has been compromised as a result of the temporary bike lane
- Recommendations to reduce the risks created by cyclists by imposing speed limits, monitoring bicycle speeds and placing security cameras throughout the park
- The increase in pedestrian and bicycle traffic on the Stanley Park seawall in the past several years
- Suggestion to remove the Stanley Park Horse Carriage in order to reduce congestion in remaining the vehicular lane
- The Mobility Study does not provide data to support the assertion that the bicycle lane will have an impact on greenhouse gas emissions
- Suggestion to hold a referendum on the inclusion of a bicycle lane in Stanley Park
- Suggestion that the Stanley Park Horse Carriage be permitted to travel in the bike lane
- Concern with the concrete barricade between the vehicle and bike lane

- Challenges navigating motor coaches through Stanley Park with the current lane configuration
- The importance of keeping options available to allow all to use Stanley Park

## **STAFF REPORTS**

### **1. Colonial Audit - Update**

Spencer Lindsay, Reconciliation Planner, Park Board, led the review of a presentation providing an update on the colonial audit and highlighted:

- Timeline of the colonial audit and progress since the November 2021 update to the Board
- Nahanee Creative Inc. has been engaged as the design consultant for the report and will also develop the communications strategy
- Dr. Selena Couture has been retained as the subject matter expert and will be sharing her research and providing advice on the structure and tone of the document
- Updated directions:
  - Focus on Stanley Park as “ground zero” of colonial impact
  - Gathering stories, not case studies

- Reduced focus on a “data driven” process
- Reflections and learnings from the process to date:
  - Some subtle resistance and trepidation encountered at times
  - Lack of capacity to support the colonial audit
  - Roadblocks, inefficiencies, inherited decisions and inequities in the system
- Effects on staff:
  - Expectation that the Colonial Audit will solve other departments’ stagnancy in addressing reconciliation
  - Mental, emotional and spiritual impact experienced by the Reconciliation Team while conducting the colonial audit
- Next steps.

S. Lindsay responded to questions from the Board. There was discussion on:

- Suggestion to utilize post-secondary students to undertake the data analysis
- Whether consideration has been given to the way the stories will be told
- The decolonization action plan will be developed after the colonial audit is completed
- Suggestion that an update on the colonial audit and decolonization as part of the orientation of newly elected Commissioners
- The need for people of all ages to engage in reconciliation.

Members of the Park Board Leadership Team presented the General Manager’s Report and highlighted:

- The Decolonization, Arts and Culture team’s announcement that the video series “Doing it for Love: Five Stories from Creative Communities in a Global Pandemic” is now publicly available on the [Park Board YouTube channel](#)
- Creation of a pop-up indoor skateboard park on the dry floor in the Vancouver Curling Club at the Hillcrest Community Centre:
  - Drop-in skateboarding sessions will be offered from July 2 to August 12, 2022
  - Skateboard lessons for neurodivergent children and youth will be provided by the Spectrum Skateboard Society
- Construction of the new Champlain Heights Playground is expected to commence in August 2022, with an expected completion date of March 2023, subject to lead times of materials and equipment
- The Park Board will be participating in the Pride Parade on July 31, 2022 from 12:00 pm to 3:00 pm

- Upcoming Council business related to or impacting parks and recreation:
  - Council will reconvene on July 22, 2022 to continue debate and discussion on the Vancouver Plan from July 6, 2022

## **MEMBERS' MOTIONS**

### **1. Park Board Staff to Maintain all Public Parks Under Park Board Jurisdiction**

Commissioner Irwin introduced the motion and responded to questions from the Board.

#### **Main Motion**

MOVED by Commissioner Irwin

SECONDED by Commissioner Mackinnon

#### **WHEREAS:**

1. At its July 9, 2018 meeting, the Vancouver Park Board approved a vision-plan for the Westbank Oakridge development, which includes 9 acres, some of which is 'airspace' park located over a privately-owned mall;
2. The new park will be maintained by workers contracted by the mall owners;
3. Very experienced, capable Park Board staff may have their work contracted out; and
4. The Park Board gardeners and staff already maintain 'green roofs' (Coal Harbour, Harbour Green Park).

#### **THEREFORE BE IT RESOLVED:**

- A. THAT the Vancouver Park Board have fully qualified Park Board staff maintain and carry-out all work for any future, or proposed 'airspace' parks, similar to, but not including the new 'airspace' park at Oakridge Centre Mall with the Westbank development, or in all parks that are in any way different from traditional, surface parks;
- B. THAT the Vancouver Park Board write management of the Oakridge development to request that Park Board staff be contracted to carry-out work in the new park at Oakridge Centre; and
- C. THAT only Park Board staff maintain and tend Vancouver Park Board public parks, and lands under Park Board jurisdiction.

### **Amendment to the Main Motion**

SECONDED by Commissioner Dumont

THAT the motion be amended as follows:

- A. THAT Vancouver Park Board staff are consulted in the creation of any future, or proposed 'airspace' parks or in all parks that are in any way different from traditional, surface parks;
- B. THAT the Vancouver Park Board write management of the Oakridge development to request that Park Board staff, where feasible, be contracted to carry-out horticultural services in the new park at Oakridge Centre;

- D. FURTHER THAT where contracting out is required, it is in consultation with any affected union group through the City of Vancouver Contracted Services Committee.

**Question on Item A**

## **2. Creating a Sonic Park**

At this point in the proceedings, Commissioner Mackinnon stepped down as Chair in order to introduce a motion and to participate in the discussion. Commissioner Giesbrecht, as Vice-Chair, assumed the chair.

Commissioner Mackinnon introduced the motion and responded to questions from the Board.

MOVED by Commissioner Mackinnon

SECONDED by Commissioner Irwin

WHEREAS:

1. One of the greatest Canadian composers, R. Murray Schafer (1933 – 2021) invented the concept of Acoustic Ecology in the City of Vancouver in the 1970s, defining it as “the study of the Soundscape – the sounds in our everyday environment – in relationship to life and society” in the 1970s;
2. The concept of Soundwalks – a walk focused on listening to that environment – was first invented by members of the World Soundscape Project under the leadership of R. Murray Schafer in Vancouver in the 1970s; that work has led to a worldwide Soundscape and Soundwalk movement; and
3. Vancouver composer Hildegard Westerkamp is internationally recognized as one of the foremost creators of Soundscapes and Soundwalks in the world.

THEREFORE BE IT RESOLVED THAT the Vancouver Park Board investigate the creation of a sonic park to commemorate that unique legacy featuring an interactive sonic environment utilizing natural sounds to create a sonic oasis in the busy and noisy city of Vancouver.

### **3. Vancouver Park Board's Approach to Climate Change**

Commissioner Dumont introduced the motion and responded to questions from the Board.

MOVED by Commissioner Dumont  
SECONDED by Commissioner Demers

#### **WHEREAS:**

1. Significant policy work has been done on a global scale by the United Nations Intergovernmental Panel on Climate Change (IPCC), but much of this work will need to be implemented on more local scales;
2. In January 2019, the City of Vancouver became one of the first cities in the world to declare a Climate Emergency. This declaration was in direct response to the landmark IPCC report released in the fall of 2018 calling for urgent action to limit global warming to 1.5°C;
3. The City of Vancouver passed a Climate Emergency Action Plan in 2020, and in November 2021, approved recommendations presented in the Big Move 6 (BM6) – Natural Climate Solutions report that focussed on carbon sequestration targets. Many of the projects referenced in the BM6 report, such as urban forest expansion, Lost Lagoon rehabilitation, and the expansion of naturally managed areas, will be led by Park Board staff. Other relevant Big Moves include Transportation and Buildings, but an action plan specific to the necessary changes to Park Board service delivery has not yet been developed;
4. The Park Board manages extensive municipal lands, facilities, and tree canopy within Vancouver. It is also responsible for significant capital and operational budgeting and spending. Connection to Nature and Equity are two key themes of VanPlay (2020), and the Board is well-placed for institutional leadership in the climate realm, with potential replicability for other jurisdictions; and
5. As evidenced by sea level rise and coastal park damage experienced by recent extreme weather events, such as the king tide and winter storms that occurred this past winter, parks and recreation specific climate adaptation will be key to future planning. The endorsed Capital Plan (2023-2026) identifies and allocates 15.5M to address coastal adaptation planning and implementation, among other initiatives in response to climate change.

#### **THEREFORE BE IT RESOLVED:**

- A. THAT the Vancouver Park Board direct staff to conduct an audit, informed by the most recent climate science, of existing parks and recreation capital projects and operational systems with the aim to adapt them through the lens of GHG reduction and climate change mitigation; and that staff prioritize this work by redirecting

existing resources and/or by seeking funding for additional resources through the next budget process;

- B. THAT the Park Board direct staff to prioritize, accelerate and consider expansion of any projects currently on record that aim to advance climate change mitigation and adaptation actions for the organization, reassess projects that do not, and report back to the Board with recommendations;
- C. THAT staff include a “Climate Considerations” section in all Park Board reports to ensure that the climate emergency lens is applied to all future projects and initiatives; and
- D. THAT Park Board staff develop a climate change mitigation and adaptation dashboard that can track the progress of the adaptation of parks and recreation capital projects and operational systems, and that this information be reported to the Board annually.
