# 2. Collingwood Park Renewal – Concept Plan

lan Stewart, Manager of Park Development, Park Board, introduced David Yurkovich, Landscape Designer, Park Board.

D. Yurkovich led the review of a presentation on the Collingwood Park renewal concept plan and highlighted:

- Project timeline
- Site context and background of Collingwood Park
- Findings from Round 1 and 2 of public engagement
- Concept plan:
  - Playground
  - Splash pad
  - Plaza / stage
  - Multi-use court with skateboard amenity
- Estimated costs and schedule.

Park Board staff responded to questions from the Board Committee. There was discussion on:

- The rationale for not including an off-leash dog area in Collingwood Park:
  - Suggestion that specific times be allocated for the utilization of the park as an off-leash dog area
- Concern regarding the liability associated with trampolines
- The additional cost and maintenance associated with a spray park with a recirculation system.

## 3. The Great Outdoors Comedy Festival – Special Event

Octavio Silva, Manager, Business Development, Park Board, led the review of a presentation on the proposed special event and highlighted:

- Background of the Great Outdoors Comedy Festival and the event organizer

- Key event parameters
- Preliminary site plan
- Indigenous representation
- Other considerations
- Event benefits
- Next steps.

Park Board staff responded to questions from the Board Committee. There was discussion on:

- Risk mitigation measures that will be implemented to avoid damage to neighbouring facilities
- Potential for the Great Outdoor Comedy Festival to be a multi-year event, if the 2023 festival is successfully executed

Traffic management and parking plans will be instituted for the special event.

The Board Committee heard from one speaker who spoke in support of the staff recommendation.

THAT the Vancouver Park Board approve an application from Trixstar LIVE to host The Great Outdoors Comedy Festival at Brockton Cricket Fields in Stanley Park on Friday, September 15, Saturday, September 16 and Sunday, September 17, 2023, from 5:00 to 11:00 pm daily, with all arrangements to the satisfaction of the General Manager of the Park Board; and
- B. THAT the Park Board approve an application from Trixstar LIVE for a Special Event Permit from the BC Liquor and Cannabis Regulation Branch to serve alcohol at the aforementioned location and dates, with a maximum capacity of 10,000 guests daily.

## 1. Tree Planting

Commissioner Howard gave notice of motion on the following:

## THEREFORE BE IT RESOLVED:

- A. THAT staff coordinate continuously with City Council to plant 100,000 new trees by 2026 with the goal of increasing our tree canopy, in addition to replacing aging and damaged trees as needed;
- B. THAT staff develop a program to encourage private dedication and corporate sponsorships of trees on sidewalks, boulevards and parks;
- C. THAT staff work with MST to advance their proposal to plant thousands of sequoia trees in Stanley Park;
- D. THAT staff prioritize addressing the inequity of canopy cover across the city by planting trees in urban heat spots, and
- E. THAT staff present a preliminary report on its strategy to work with City staff on planting 100,000 new trees over four years in Q2, 2023.

#### **ENQUIRIES**

- 1. A Board member enquired if consideration of the motion Water Works By-law Exemptions and/or Viable Exceptions for Notable Decorative City Water Features recently presented at City Council, I would like to request that staff's upcoming update on decorative fountains include a plan for re-activating selected fountains immediately, identifying those that should be prioritized for upgrades and those that should be removed and replaced with usable park space.
- 2. A Board member asked how staff are responding to emails regarding a potential turf field at Moberly or Ross parks.
- 3. A Board member requested an update on the removal of the Stanley Park temporary bike lane and what percentage has been removed.
