#### 1. Burrard Slopes Park Building Removal – Contract Award

The Director of Planning and Park Development introduced the item, and the Manager of Park Development along with the Landscape Architect provided an overview of the proposed contract

award for the removal of buildings at the Burrard Slopes Park site. Subsequently, the aforementioned staff responded to questions related to:

- Impact on commercial and industrial space
- Property acquisition
- Public engagement and future events
- Condition of the buildings and feasibility of repurposing
- History of the park and future plans

The Committee heard from one speaker who spoke to other aspects of the recommendations.

THAT the Committee recommend to the Board:

- A. THAT the Vancouver Board of Parks and Recreation ("Park Board") authorize staff to negotiate to the satisfaction of the Park Board's General Manager and the City's Chief Purchasing Officer and enter into a contract with Scott Special Projects Ltd. (Scott Construction), for the removal of four existing buildings at the future Burrard Slopes Park site, for a term of approximately seven (7) months, or until services are complete, with an estimated contract value of \$1,118,421.70, plus applicable taxes over the approximate seven (7) month term, to be funded through the 2019 2022 Park Board Capital Plan.
- B. THAT the City's Chief Purchasing Officer and Park Board's General Manager be authorized to execute on behalf of the Park Board the contract contemplated by A above.
- C. THAT no legal rights or obligations will be created by the Park Board's adoption of A and B above unless and until such contract is executed by the authorized signatories of the City as set out in A and B above.

#### 2. Sport Field Development Update

The Director of Planning and Park Development introduced the item, and the Manager of Park Development, along with the Project Manager, <u>presented an update</u>.

# 3. General Manager's Report

The Director of Planning and Park Development presented the <u>General Manager's Report</u>, highlighting:

- Construction for the Oppenheimer Park playground renewal targeted to commence in spring 2023 following to recent receipt of a Tire Stewardship of BC Grant.
- Vancouver Tennis Society, in partnership with the Park Board, received grants from ParticiPACTION to host sport events.
- Activities and events supporting National Truth & Reconciliation Day by the Decolonization Arts & Culture (DAC) team and the collaboration with Community Centre Association partners.
- The recent recognition of the Vancouver Park Board as an international leader in city greening as a result of the pollinator meadows project.
- Upcoming Council business related to or impacting parks and recreation:
  - Report titled "Contract Award for Marpole Community Centre Construction Project"
  - Report titled "Provincial 'Growing Communities Fund': Allocation to Temporary Plazas, Turf Field and Moberly Park and Spray Park at Ross Park"
- Board briefing memos and emails issued from September 25, 2023 to October 16, 2023.

# MEMBERS' MOTIONS

#### 1. Off Season Usage Parking Pass – Jericho Beach Park

Commissioner Howard introduced the motion and responded to questions.

MOVED by Commissioner Howard SECONDED by Commissioner Jensen

THAT the Board of Parks and Recreation, effective immediately, approve a new off season usage (October 1, 2023 to March 31, 2024) parking pass at Jericho Lot (Lot 69);

FURTHER THAT the General Manager has delegated authority to establish an appropriate price for the off-season parking pass for the 2023 year. Future off-season parking pass price setting will align with the usual Board fees and charges process.

#### 2. Mural and Sports Court Activation at Sunset Beach Park

Commissioner Bastyovanszky introduced the motion and responded to questions.

MOVED by Commissioner Bastyovanszky SECONDED by Commissioner Haer

#### WHEREAS:

- 1. In accordance with the Vancouver Charter, the Park Board has exclusive jurisdiction and control over park land use in the City of Vancouver, including any events, activities, programs, fees, structures, and improvements that occur within designated parks;
- 2. Sports transcends cultural and socioeconomic barriers. It brings people together and fosters a sense of community; By providing and enhancing spaces for the community to play and connect in our city, we are helping to promote social cohesion and enhance well-being;
- 3. Sunset Beach is a popular Vancouver gathering spot for locals and tourists alike, including the Sunset Beach sports pad which offers multiple opportunities for community sports activities;
- 4. There is currently limited outdoor sporting infrastructure in the area, making the Sunset Beach sports pad a valuable asset for promoting active living;
- 5. The community engagement for the 30 year plan for the West End Waterfront completed its most recent round in the Fall of 2023, early feedback showed support for more sports court activations in the West End, such as soccer, basketball, and roller sports;
- 6. The Park Board received an offer of a donation from 'Art X Sport' to update the mural in Sunset Beach Parking lot and to renew and expand the sports courts;
- 7. By activating the Sunset Beach sports pad, we can provide more opportunities for residents to engage in physical activity, particularly in sports like basketball, soccer, and roller hockey. These sports are popular and accessible to people of all ages and income levels. Such inclusivity aligns with the City of Vancouver's healthy community strategy and its commitment to promoting active living among its residents, and is inline with Sunset Beach as a designated quiet beach;
- 8. In addition to sports activities, the Sunset Beach sports pad offers an opportunity to combine sport activations with other activation projects such as a mural project and other arts and community activations;
- 9. The Sunset Beach sports pad is an ideal location for an Art X Sport activation project. The central location and proximity to public transportation make it easily accessible to residents from various parts of the city. The proximity to the beach, seawall, and water also would add to the overall appeal of a multi-pronged activation. It would provide a unique and enjoyable experience for both players and spectators, attracting visitors from near and far;
- 10. Local artist, Carling Jackson of Art X Sports, is a professional, award-winning athlete portrait artist who primarily focuses on using contemporary art to effect change and make the world a better place. She was the first sports artist in FIFA history to paint at a World Cup and is the most commissioned artist by athletes in

the world. She has been commissioned to paint over 170 paintings for athletes across 17 leagues and 22 countries; and

11. Given the various community needs for sporting facilities and arts related activations, the potential benefits of activating the Sunset Beach sports pad should be seen as a priority opportunity to accomplish these community objectives in a timely, relatively low cost manner. It is therefore crucial for the Vancouver Board of Parks and Recreation to prioritize this project.

#### THEREFORE BE IT RESOLVED:

- A. THAT the Board directs staff to explore the potential donation of an art mural and work with the 'Art X Sport' group to activate and renew the existing sports court space at Sunset Beach parking lot with a sport-themed mural, ideally in time for Summer 2024.
- B. THAT staff be directed to explore and facilitate potential funding sources, including from private contributions, sponsorships and the city, to advance a temporary 'pop up sports activation' space at Sunset Beach parking lot, adjacent to the existing sports court, and to report back on possible scope, costs, timelines, and program ideas with results reported back to the Board in Q12024 for decision.
- C. THAT for staff to work with city staff on the potential of a change of use to allow food and beverage at Sunset Beach parking lot, with accessible, affordable options, following the precedent at Plaza of Nations.

#### Amendment to the Main Motion

MOVED by Commissioner Christensen SECONDED by Commissioner Virdi

THAT the following be inserted between A and B:

THAT the Board directs staff to work with user groups and identify stakeholders of the Sunset Beach sports court activation area.

- A. THAT the Board directs staff to explore the potential donation of an art mural and work with the 'Art X Sport' group to activate and renew the existing sports court space at Sunset Beach parking lot with a sport-themed mural, ideally in time for summer 2024.
- B. THAT the Board directs staff to work with user groups and identify stakeholders of the Sunset Beach sports court activation area.
- C. THAT staff be directed to explore and facilitate potential funding sources, including from private contributions, sponsorships and the city, to advance a

temporary 'pop up sports activation' space at Sunset Beach parking lot, adjacent to the existing sports court, and to report back on possible scope, costs, timelines, and program ideas with results reported back to the Board in Q12024 for decision.

D. THAT for staff to work with city staff on the potential of a change of use to allow food and beverage at Sunset Beach parking lot, with accessible, affordable options, following the precedent at Plaza of Nations.

# NOTICE OF MEMBER'S MOTIONS

# 1. An Inclusive Children's Water Park at Ross Park - Bridging the Gap in South East Vancouver, an Underserved Neighborhood

Commissioner Haer submitted Notice of Motion on the above-noted matter. The motion below may be placed on the Board meeting agenda of October 30, 2023, as a Member's Motion.

#### THEREFORE BE IT RESOLVED:

- A. THAT the Vancouver Board of Parks and Recreation direct staff to construct an inclusive children's water park at Ross Park, Vancouver, as a crucial step towards bridging the recreational gap in this underserved neighbourhood.
- B. THAT staff thoughtfully design the water park to ensure accessibility for children of all abilities, including those with physical, sensory, or cognitive challenges. It should feature water play elements that engage and stimulate children's senses, providing a safe and enjoyable space for everyone to come together. The inclusive children's water park at Ross Park will not only enhance the quality of life for local children but also create a focal point for community gatherings and activities, fostering a sense of pride and unity among the residents.
- C. THAT staff ensure the project will be undertaken with community engagement at its core, seeking input and feedback from the residents of South East Vancouver, community organizations and local stakeholders to incorporate their ideas and preferences into the park's design to ensure the project's success and sustainability.
- D. THAT staff work with Vancouver City Council to allocate adequate funds and resources to initiate the planning, design, and construction of the inclusive children's water park at Ross Park.
