### ANNOUNCEMENTS

Commissioner Bastyovanszky announced that the Vancouver Park Board received an open letter of support from Minnesota's elected Park Board and Minnesota's Mayor. Commissioner Bastyovanszky thanked Minnesota's Mayor for supporting Vancouver's elected Park Board.

Commissioner Jensen recognized National Indigenous People's Day on Friday, June 21, 2024. The Park Board hosted an outdoor movie at Ceperley Meadow titled "Slash/Back". To prep the field for the event, Director Gandha and the Park Ops Team utilized the new goose poop scoopers to maintain cleanliness, enhancing the experience for attendees. Commissioner

Jensen thanked Director Gandha and the Park Board staff for their ongoing efforts to beautify parks.

Commissioner Haer attended the 39<sup>th</sup> annual memorial for the 331 victims of the Air India bombing on June 23 at Stanley Park's Ceperley Playground. The memorial honoured the 329 victims, including 82 children, and two baggage handlers in Narita, Japan.

## **2. General Manager's Report**

The General Manager presented the General Manager's Report, highlighting:

- KCCA Food Security Initiatives – Kitsilano War Memorial Community Centre Association has developed various programs supporting food security and food culture, and created a working group with ten organizations to unify community services. They are also hosting the Park Board's Artist in the Kitchen pilot program. Staff are pleased to celebrate the successes of our important joint operating partners in our community centres.

- Rupert and Renfrew Stations Area Planning – On June 29, Phase 3 of the Rupert and Renfrew Stations area planning will begin. The engagement covers the draft land use plan and amenity priorities for 25 years in an area of significant population growth. The draft plan includes Still Creek and park expansions, park amenity funded improvements, and the renewal of the Renfrew Park Community Centre.
- Art in Andy Livingstone Park – Art in the Park at Andy Livingstone is an annual artist in residence project through the Urban Park Activation Team. The project focuses on destigmatization and community building through creative practices and connection with Indigenous Elders. The opening celebration is on June 27, with ongoing sessions on Thursdays and Sundays from 2 - 6pm throughout the summer.

- A. THAT the Vancouver Park Board directs staff to conduct a review of any and all trusts, bequests and leases pertaining to parks and recreation facilities in Vancouver to identify risks and potential exposure should the elected Park Board be abolished.
- B. THAT all 240+ parks and 40+ recreation facilities be included in such review, especially including Stanley Park.
- C. THAT such review shall be delivered to Commissioners in camera by Q2/2025; Issues of urgent concern may be raised in advance if and when they are identified; and

- D. THAT should staff need an exemption from this Board's December 11, 2023, motion to not allocate any resources towards a transition working group, it should be considered granted for the purposes of this motion.
