- B. THAT the Board direct staff to enable (insert wording from OPTION 1 or 2) as outlined in Appendix B:

OPTION 1 – *Two-Way Beach Avenue with Direct Exit from Stanley Park* - to enable traffic from Stanley Park to exit onto Beach Avenue in the development of the detailed design for Phase 1, in alignment with the Vancouver City Council decision to reinstate two-way traffic on Beach Avenue west of Denman Street, through either one of two sub-options:

- OPTION 1A – Beach Avenue/Park Lane Intersection Change Only
- OPTION 1B – Stanley Park Drive Reconfiguration

OPTION 2 – *Two Way Beach with No Direct Exit from Stanley Park* - to not enable traffic from Stanley Park to exit onto Beach Avenue, and instead to maintain existing routing within Stanley Park.

- C. THAT the Board direct staff to respond to Council's interest in a strategy to scope efforts around foreshore mitigation and investments in the Seawall, by sharing with Council the findings of the Park Board's Climate Adaptation Response for Parks and Beaches when this work is complete.

1. Adopting the UNDRIP Action Plan

Commissioner Jensen introduced a motion titled “Adopting the UNDRIP Action Plan”.

MOVED by Commissioner Jensen

SECONDED by Commissioner Christensen

WHEREAS

1. On June 11, 2016, the Vancouver Board of Parks and Recreation (“Board”) adopted 11 Reconciliation Strategies in response to the Calls to Action provided by the Truth and Reconciliation of Commission of Canada (TRC). This strategy set the Park Board on a new trajectory toward Reconciliation;
2. In 2018 the Board endorsed the Reconciliation Mission, Vision, and Values statement, which has guided the future growth and evolution of reconciliation within the Board;
3. In 2018 the Board began a Colonial Audit to document the ways in which colonialism is woven into the Board from strategic decision levels through to day-to-day operations. The most recent update was adopted by the Board in July 2022;
4. In November 2019 the provincial government passed the Declaration on the Rights of Indigenous Peoples Act into law;
5. VanPlay Framework, a reference guide to Vancouver’s Parks and Recreation Services Master Plan (consisting of 4 comprehensive reports). VanPlay Goal 9 directs the Board to “seek truth as a foundation for Reconciliation”. The VanPlay Playbook directs Park Board to “focus reconciliation efforts on decolonizing the Park Board and relationship building with the Musqueam, Squamish, and Tsleil-Waututh Nations”;
6. On June 25, 2024, Vancouver City Council endorsed the UNDRIP Action Plan and directed City staff to begin implementation of the UNDRIP Action Plan deliverables over the next five years;
7. On July 3, 2024, the Park Board General Manager received a letter from the City Clerk notifying them of the City Council approval of the UNDRIP Action Plan;

AND WHEREAS for many years the Board has been at the forefront of intergovernmental approaches to reconciliation with First Nations, including the work of the Stanley Park Intergovernmental Committee and Working Group on the Stanley Park Comprehensive Plan.

THEREFORE BE IT RESOLVED

- A. THAT the Board reaffirms its commitment to reconciliation and the 2018 Board endorsed Reconciliation Mission, Vision, and Values.
- B. THAT the Board adopts the City of Vancouver UNDRIP Action Plan in the form approved by Council on June 25, 2024.
- C. THAT the Board directs staff to collaborate as necessary on the implementation within Board jurisdiction of relevant Actions of the UNDRIP Action Plan.
- D. THAT the Board directs staff to report back on financial and resource requirements for the implementation.

1. Parks and recreation facilities in Vancouver are in many cases subject to obligations under underlying trusts, bequests and leases;
2. It is unknown which of these trusts, bequests and leases may have been premised on the existence of a duly elected Park Board to oversee such parks and recreation facilities; and
3. It is currently unknown what is the level of risk and exposure under such trusts, bequests and leases should the Mayor's motion to abolish the elected Park Board proceed.

THEREFORE BE IT RESOLVED

- A. THAT the Vancouver Park Board directs staff to conduct a review of any and all trusts, bequests and leases pertaining to parks and recreation facilities in Vancouver to identify risks and potential exposure should the elected Park Board be abolished;

FURTHER THAT all 240+ parks and 40+ recreation facilities be included in such review, especially including Stanley Park;

AND FURTHER THAT such review shall be delivered to Commissioners in camera by Q2/2025; Issues of urgent concern may be raised in advance if and when they are identified.

- B. THAT should staff need an exemption from this Board's December 11, 2023 motion to not allocate any resources towards a transition working group, it should be considered granted for the purposes of this motion.

THAT The Vancouver Park Board direct staff to report back in Q2 2025 with a performance review of the services provided by Real Estate and Facilities Management (REFM) towards planning of renewal and maintenance of Park Board facilities, including a historical comparison to before REFM took over in approximately 2009, and how the Park Board used to do capital planning and maintenance before that.
- B. THAT the Board direct staff to provide an interim report on the foregoing subject matter at the beginning on the fall 2024 session.
- C. THAT the Board direct staff to have a regular cadence of public reporting on the performance of REFM against its agreed service levels, including service of requests made via 3-1-1.
- D. THAT the report back shall include any recommendations on potential changes to the operating protocol between Park Board and REFM that would enhance planning and maintenance of Park Board facilities.
