

PARK BOARD MEETING HIGHLIGHTS — January 20, 2025 —

The following information is intended to provide a brief overview of the Board's governance work at the Committee and Board meetings. The full agenda, meeting materials, video clips and official minutes can be found on the Park Board website.

STAFF REPORTS / PRESENTATIONS

Sponsorship & Sponsorship Naming Rights Policy

The Board approved the Sponsorship & Sponsorship Naming Rights Policy with <u>amendments</u>. This policy rescinds the 2007 Naming Rights Policy and the 1995 Sponsorship Guidelines and implements the 2025 Sponsorship Policy contained in Appendix C. The Board approved amendments to reduce the delegated authority value to \$250,000, and that section 6.2 of the policy statement be amended to include consultation with community centre associations, key partners and rights holders on aspects of sponsorship and sponsorship naming initiatives that could have impact on their operations.

Stanley Park Hemlock Looper Response - Bid Committee Change Order

The Board received for information the <u>Stanley Park Hemlock Looper Response Bid Committee Change Order</u> administrative report. The report informed the Board that a change order with a value of \$3 million has been approved and awarded to start using some of the budget for Phase 3 of the mitigation work under the current contract with B.A. Blackwell & Associates Ltd. to expedite high-priority mitigation work.

2024 Year in Review

The Board received a presentation on the <u>2024 Year in Review</u>. The presentation provided an outline of the work delivered by staff on a range of priorities and a variety of projects and initiatives for Vancouver's parks and recreation spaces. This included capital delivery, improved parks, playgrounds, facilities and amenities, the advancement of key policies and strategies, over 1,500 special events and the planting of over 25,000 trees in Stanley Park.

Commissioner Liaison Appointments

The Board received for information a memo outlining the <u>2025 Commissioner Liaison Appointments</u>. Commissioners were appointed to liaison roles for community centre associations and societies, Park Board advisory groups, community partners and groups, statutory committees and board, and Council advisory bodies across the city.

- Bloedel Conservatory Pathway Reconstruction Bloedel Conservatory reopened its doors to the public on January 4, 2025, following a 2-month pathway reconstruction project.
