

## NOTICE of MOTION

Submitted at the Regular Board meeting held on May 12, 2025

## Think 50 Metres

SUBMITTED BY: Commissioner Virdi

## WHEREAS:

- 1. Access to well-distributed, high-capacity public aquatic facilities is vital for fostering community health, supporting youth development, enabling lifelong fitness, and meeting the recreational and competitive needs of a growing and diverse population;
- 2. The City of Vancouver has experienced a significant decline in aquatic capacity over the past two decades, marked by the closure or decommissioning of pools in Sunset, Mount Pleasant, and the Langara YMCA, and with the Vancouver Park Board's VanSplash report identifying five additional indoor facilities: the Vancouver Aquatic Centre, Kerrisdale, Britannia, Lord Byng, and Templeton as being at the end of their functional lifespan, resulting in widespread service gaps across multiple neighbourhoods;
- 3. The recent decision regarding the replacement of the Vancouver Aquatic Centre (VAC) opts for a 25-metre pool, falling short of a 50-metre facility long advocated for by athletes, swim clubs, and aquatic organizations, and limiting the city's ability to support high-performance training, competitions, and broad community programming;
- 4. The VanSplash Aquatics Strategy emphasizes the importance of balancing aquatic facilities across the city, while the redevelopment of the Vancouver Aquatic Centre highlighted the need to support both competitive swimming and diving, along with recreational pools, to maintain broad community access to all forms of swimming;
- 5. South Vancouver remains notably underserved in terms of aquatic infrastructure, with increasing demand from families, seniors, newcomers, and recreational users who lack access to a full-service aquatic facility within reasonable proximity;
- 6. Member of Parliament Taleeb Noormohammed has publicly recognized the importance of a 50-metre pool in Southeast Vancouver and has committed to seeking federal funding to support its development as part of broader community investment priorities:

## THEREFORE BE IT RESOLVED:

A. THAT the Vancouver Board of Parks and Recreation reaffirm its commitment to ensuring equitable access to aquatic services across all regions of the city by prioritizing the development of a new 50-metre aquatic facility preferably in South Vancouver;



- B. THAT the Board direct staff to engage with MP Taleeb Noormohammed, the provincial government and the City of Vancouver to identify and secure funding sources to support the planning, design, and construction of this facility;
- C. THAT the Vancouver Park Board staff be directed to ensure that the growing aquatic needs of South Vancouver are meaningfully incorporated into the update underway to the "Recommendations for Service Delivery" section of VanSplash, including an overview of service gaps, population data and preliminary siting considerations for a 50-metre pool in South Vancouver.
- D. THAT the Vancouver Park Board staff be directed to produce, at minimum, a preliminary report on the state of Vancouver's aquatic infrastructure by Q1 2026, including an overview of service gaps and preliminary siting considerations for a 50metre pool in South Vancouver.
- E. THAT the Vancouver Board of Parks and Recreation urge Vancouver City Council to include this project in the forthcoming Capital Plan, in recognition of long-standing community demand, regional need, and the opportunity to create a legacy public amenity for generations to come.

Across our city the need for spaces for gathering and physical activity is increasing. Last Canada Day, while standing among friends and neighbours at Sunset, I made a personal commitment to advocate as strongly as I can for the funding needed to bring this new pool to life – and I continue to stand firmly by that promise.

This project is about so much more than just a pool. It's about creating a place where people can come together, stay active, and feel connected to their community. It's about fairness, inclusion, and investing in a neighbourhood that truly deserves our attention and support.

If re-elected as the MP for Vancouver Granville, I will continue to advocate for federal support for other pools and community centres across and near Vancouver Granville. From Kitsilano to Connaught, there is a real need for infrastructure that supports a healthy population and I look forward to working with all levels of government to improve the quality of life of all our constituents.

Dear Vancouver Park Board Commissioners and City Councillors,

We are writing from B.C Khalsa Darbar Society with a renewed call to action: South Vancouver needs a public pool — and we need the City to honor the commitment made to our community.

Once, Sunset Community Centre was home to a pool that served generations of residents. It was removed with assurances that it would be replaced. That commitment has faded into silence. Since then, access to aquatic facilities in South Vancouver has only worsened. The recent closure of the Langara YMCA, previously the closest alternative, has left tens of thousands of residents with no nearby public pool.

This isn't just about a building. This is about fairness, health, and dignity.

South Vancouver has for too long been left behind in civic planning and investment. While other parts of the city have seen new pools, upgrades, and expansions, our neighbourhood continues to be overlooked — despite being home to many low-income families, newcomers, seniors, and young people. These are communities who rely most on affordable, local recreational services.

The need for aquatic facilities in our neighbourhood goes beyond recreation. Swimming is a life skill. For many elders, water therapy is essential for pain management and mobility. For youth, pools offer safe, structured environments to build confidence, skills, and community. And for newcomers, they are often the first place families connect to city life.

Despite this, South Vancouver residents were largely left out of the consultation process that shaped recent recreation planning. Many never heard about the surveys or engagement sessions. And when a motion supporting a new Sunset pool was brought to the Park Board, it was blocked — not only rejected, but denied even a fair hearing. The public was not allowed to speak. That lack of openness is not just disappointing — it undermines the very principles of public service and participatory democracy.

Communities thrive when they are heard, respected, and supported. The people of South Vancouver are not asking for special treatment. We are simply asking for the same level of care and investment afforded to other parts of the city. A public pool at Sunset isn't just overdue — it's necessary, and it's right.

We urge the Park Board and City Council to revisit this issue with urgency, transparency, and integrity. Let's move forward with honesty, listen to the communities that have been left out for too long, and deliver on the promise that was made.

## Subject: Need for a Pool at Sunset Community Centre

Dear Members of the Vancouver Board of Parks and Recreation and City of Vancouver Council,

We are members of the Percy Norman Masters Swim Club. Many of our members reside in East and South Vancouver, but we swim at Hillcrest Pool.

The members of our swim club tremendously benefit from the City's recreational services. We greatly appreciate them, but we are seeing a general overcrowding of facilities, compounded by a lack of facility availability and services. We have gone from being able to swim as a club for 10 months of the year to only eight. In addition, the lack of a 50-metre pool hinders our ability to train and host events, the latter which bring economic activity to our club, community and city.

South Vancouver is one of the more underserved areas in the city for access to public amenities — especially aquatic facilities. The community once had a pool at Sunset Community Centre, which was decommissioned with the explicit promise by the Vancouver Parks Board that it would be replaced. Yet years have gone by, and that promise remains unfulfilled. In that time, the closure of the Langara YMCA has only compounded the gap, stripping the community of the nearest remaining pool and leaving families, seniors, youth, and newcomers to Vancouver with no realistic access to vital aquatic programming.

Aquatic facilities are critical to a healthy and inclusive city. Our members range from former competitive swimmers to those who are new to swimming, from age 30 to over 75, to those born and raised in Vancouver to those new to Canada. For the latter group, there is an important safety consideration in learning to swim in a city surrounded by water.

We are also aware that pools provide essential services like swimming lessons, rehabilitation, low-impact fitness for seniors, and culturally relevant programs for diverse communities. They also offer places for youth to gather, learn, and grow — especially important in a time when mental health and social connection are of such concern.

This is not just about a pool — it's about fairness and access. South Vancouver has often been overlooked for recreational infrastructure. While other neighbourhoods benefit from modernized, well-maintained aquatic centres, this community is being left behind. This disparity highlights the broader inequalities that persist in our city, and the failure to invest in South Vancouver perpetuates that imbalance.

We have become aware of a recent Park Board decision to defeat the motion calling for a new pool at Sunset, without the opportunity for public consultation and without referring the motion to committee. This troubles us. We want the opportunity to participate in these discussions since they affect us in a variety of ways – physically, economically and socially. This, in conjunction with the pool's recent decision to axe the proposed 50-metre pool downtown, only perpetuates the notion that the City doesn't want its citizens to have a voice in the decisions that shape it.

We urge the Vancouver Board of Parks and Recreation and City Council to commit to building a 50- metre pool at Sunset Community Centre and to do so through an open, inclusive, and democratic process that honours the voices of the people you serve.

The Sunset on Fraser Business Association, representing 245 businesses and property owners in south Vancouver along Fraser Street, are fully supportive of dialogue and the construction of a much-needed swimming pool at Sunset Community Centre.

Need has always been there, and it has been a point of discussion in our community for decades. Riley Park swimming pool and Killarney pool were over-crowded the moment they were built. Subject: A Call for Action - Restore the Promise of a Pool at Sunset Community Centre

Dear Members of the Vancouver Board of Parks and Recreation and City Council,

We are writing to you on behalf of the Sunset Indo-Canadian Seniors Society, a community of elders who have long called South Vancouver our home. Many of us are immigrants, grandparents, caregivers, and active members of this diverse and growing neighbourhood. We are deeply disappointed by the continued lack of action on building a new pool at Sunset Community Centre — a facility that was once promised to us and that remains sorely needed.

Years ago, the Sunset Community Centre had a pool. It was a place where our members could take part in gentle aquatic exercise, meet with friends, stay healthy, and feel included. When that pool was decommissioned, we were told that it would be replaced. But that has not happened. Instead, more facilities have disappeared — most recently, the Langara YMCA pool, which was the only other nearby option for many seniors in our community. Today, we have nowhere to go.

This lack of access is not just inconvenient—it is harmful. As seniors, many of us rely on aquatic activity to manage chronic conditions, recover from injury, and stay active in a way that is safe and low-impact. For those of us living on fixed incomes, private gyms and pools are not affordable. And for those with mobility issues, traveling across the city to use other public pools is simply not an option.

What makes this situation even more upsetting is how South Vancouver continues to be overlooked in city planning. We see other neighbourhoods receiving new facilities and upgrades, while our community — rich in culture, diversity, and history — is left behind. It feels as though our needs, especially as seniors, are not being heard or respected.

The most painful example of this came recently, when the Park Board defeated a motion supporting a new pool at Sunset without allowing the public to speak — and without even sending the matter to committee. In all our years of community involvement, we have never seen a decision like this. The lack of transparency and public input is shocking. How can decisions be made about our community without even giving us a chance to speak?

We urge you to reflect on the impact of this decision — not just on policy, but on people. Seniors in South Vancouver feel forgotten. We were promised a pool. We are still waiting.

It is time to honour that promise. Our members — and the broader community — deserve access to a public aquatic facility close to home. We deserve to be included in decisions that affect our lives. And we deserve equity in how public resources are distributed across the city.

We respectfully ask the Vancouver Park Board and City Council to revisit this issue with transparency, fairness, and compassion. Please listen to our voices. Please build the pool our

I write to you today to express the dismay and frustration from residents of South Vancouver. As the outgoing Member of Parliament I have had the privilege to serve Vancouver South for almost a decade. Through that decade I have seen and heard first hand the frustrations of residents when it comes to the inequity of amenities and resources for this side of the city. I spent a better part of my time in office advocating for the Sunset Senior's Centre which is now finally being built- primarily thanks to a federal investment of over \$10 million dollars.

During my years of advocacy for the Senior's Centre, I would often vocalize the need for a community pool as well. The neighbourhood's previous outdoor pool was decommissioned in 2007, almost 20 years ago. The nearest pool at the local YMCA has also been shut down. With density growing in the south east it is alarming to see the lack of urgency to address the need of amenities for the residents. South Vancouver is often the forgotten middle child of Vancouver. With the vocal and often affluent mobilization of the West side and the high needs in the North East, South Vancouver is filled with multigenerational families, working professionals and newer immigrants who are so busy building a life for themselves they are often left behind and forgotten, and rarely getting their fair share of community infrastructure or amenities.
