QE Park Dancing Waters Fountain

- Scope: Repair leaks; install new waterproofing membrane; mechanical & electrical repairs
- **Consultant:** Apex Building Sciences Inc.
- Contractor: Jacob Bros Construction
- **Status:** Construction (90% complete)
- Estimated completion: Summer 2025





Memorial South Park Pond

BOARD OF PARKS AND RECREATION

- Scope: Water balance assessment; install pond liner to hold water; water meter repairs
- **Consultant:** VDZ+A Consulting Inc.
- Contractor: Shangri-La Landscaping
- Status: Construction start Aug 2025
- Estimated completion: Q4 2025



- Original Scope: Replace fountain basin membrane; replace pumps; concrete repairs to fountain which sits over COV ENG Pump Station building
- **Consultant**: GHD Limited
- Status: On-hold indefinitely pending decision from COV ENG to replace roof waterproofing membrane
- Short-term: Install planters to activate the space and improve aesthetics (Q4 2025)

David Lam Fountain







- Scope: Improve drainage; replace waterproofing membrane
- Consultant: GHD Limited
- Status: Ready for tendering
- Estimated completion: Q2 2026

Communications, Other Sites, and Next Steps

- Signs will be posted to communicate water feature priority repair work.
- 15 other decorative water features are off due to by-law nonconformance. Signs inform residents of the status.
- Helmcken Park, Haro & Bute Street, Barclay Heritage Square, Davis (Pacific & Jervis), and the Laurel Street Landbridge fountains are maintained by REFM and in varying condition. These 5 "once-through" fountains are exempted in City By-laws, per 2023 Council and Park Board motions and are presently operational.
- Funding is not presently available to upgrade the 5 exempted fountains or the 15 other decorative water features in our system.
- Staff will seek funding in 2027-2030 Capital Plan to support additional water feature rehabilitation, decommissioning, and conversion projects.
